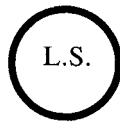
EUROPEAN COMMUNITIES (SWINE VESICULAR DISEASE)
REGULATIONS 2007

I, MARY COUGHLAN, Minister for Agriculture and Food, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No 27 of 1972), for the purpose of giving effect to Commission Directive 2007/10/EC of 21 February 2007¹, hereby make the following regulations—

1. These Regulations may be cited as the European Communities (Swine Vesicular Disease) Regulations 2007.

2. The European Communities (Swine Vesicular Disease) Regulations 1995 (S.I. No 373 of 1995) are amended in Regulation 2(1) by substituting the following for the definition of ‘the Council Directive’—

“ ‘the Council Directive’ means Council Directive No 92/119/EEC of 17 December 1992 and Commission Directive 2007/10/EC of 21 February 2007;”.
