**ROAD TRAFFIC AND VEHICLES**

**The Waiting Restrictions (Dungannon) (Amendment) Order  
(Northern Ireland) 2010**

*Made* - - - - *16th August 2010*

*Coming into operation* - *7th September 2010*

The Department for Regional Development<sup>(a)</sup> makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997<sup>(b)</sup> and now vested in it<sup>(c)</sup>.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a Notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

**Citation and commencement**

1. This Order may be cited as The Waiting Restrictions (Dungannon) (Amendment) Order (Northern Ireland) 2010 and shall come into operation on 7th September 2010.

**Amendment**

2.—(1) The Waiting Restrictions (Dungannon) Order (Northern Ireland) 2010<sup>(d)</sup> shall be amended in accordance with paragraphs (2) to (6).

(2) In Article 2 (restriction of waiting) for the words “the Schedule” substitute the words “Schedule 1”.

(3) After Article 2 insert the following Article—

“**2A.** Subject to Article 3 a person shall not cause or permit a vehicle to wait during the hours 8.30 a.m. and 6.15 p.m. on the days Monday to Saturday inclusive on the lengths of road specified in Schedule 2.”.

(4) In Article 3 (exceptions)—

(a) for the words “Article 2” substitute the words “Articles 2 and 2A”; and

- (b) for the words “the Schedule” substitute the words “Schedule 1 at any time or Schedule 2 during the hours 8.30 a.m. and 6.15 p.m. on the days Monday to Saturday inclusive”.
- (5) Renumber the Schedule as “Schedule 1”.
- (6) After Schedule 1 (as so renumbered) add the Schedule set out in the Schedule to this Order.

## SCHEDULE

Article 2(6)

### “SCHEDULE 2

#### Waiting Restriction Monday to Saturday 8.30 a.m. to 6.15 p.m.

All in Dungannon

1. Union Place (south-east side) — from a point 53 metres north of its junction with Greers Road for a distance of 48 metres in a north-easterly and south-easterly direction.
2. Union Place (north-west side) — from a point 44 metres north of its junction with Greers Road for a distance of 39 metres in a north-easterly direction.
3. Union Place (north-east side) — from a point 105 metres north-east of its junction with Greers Road for a distance of 40 metres in a south-easterly and south-westerly direction.”

## **EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order amends The Waiting Restrictions (Dungannon) Order (Northern Ireland) 2010 (“the 2010 Order”) by renumbering the Schedule as Schedule 1 and also the addition of Schedule 2. The effect of the amendments is to prohibit vehicles waiting during the hours 8.30 a.m. and 6.15 p.m. on the days Monday to Saturday inclusive on the lengths of road specified in the Schedule

A penalty charge (£60) is payable with respect to a vehicle involved in a contravention of the 2010 Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of the Order will in due course be erected on the road.
