**ROAD TRAFFIC AND VEHICLES**

**The Prohibition of Waiting (Amendment) Order (Northern Ireland) 2010**

*Made* - - - - - *26th October 2010*

*Coming into operation* - *17th November 2010*

The Department for Regional Development(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a Notice in compliance with paragraphs 1 and 3 of that Schedule.

Five representations have been received and duly considered.

**Citation and commencement**

1. This Order may be cited as The Prohibition of Waiting (Amendment) Order (Northern Ireland) 2010 and shall come into operation on 17th November 2010.

**Amendment**

2.—(1) The Prohibition of Waiting Order (Northern Ireland) 2001(d) shall be amended in accordance with paragraphs (2) to (5).

(2) In Article 1(2), for the definition of “specified road” substitute the following—

““specified road” means the carriageway of the lengths of road specified in column 1 of Schedule 1 and column 1 of Schedule 2;”;

(3) For Article 2 (prohibition of waiting) substitute the following Article—

“**2.** Save as provided in Article 3, no person shall, except upon the direction or with the permission of a constable in uniform, cause or permit a vehicle to wait wholly or partly in a specified road—

(a) during the hours and on the days specified in columns 2 and 3 of Schedule 1 respectively; or

- (b) during the hours, and on the days and dates specified in columns 2, 3 and 4 of Schedule 2 respectively.”
- (4) For the Schedule substitute the Schedule set out in Schedule 1 to this Order.
- (5) After Schedule 1 (as so renumbered) add the Schedule set out in Schedule 2 to this Order.

## **EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order further amends the Prohibition of Waiting Order (Northern Ireland) 2001 (“the Order”). The amendments prohibit waiting by vehicles, with certain exceptions, on-

- (a) the parts of Cregagh Road, Belfast, Ashley Drive and Glenburn Park, Bangor, specified in column 1 of Schedule 1 at the times and on the days specified in columns 2 and 3; and
- (b) the parts of Windsor Avenue, Belfast, specified in column 1 of Schedule 2 at the times and on the days and dates specified in columns 2, 3 and 4 respectively.

A penalty charge (£60) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of the Order will in due course be erected on the roads.
