ROAD TRAFFIC AND VEHICLES

The Roads (Speed Limit) (No. 7) Order (Northern Ireland) 2010

Made - - - - *29th December 2010*

Coming into operation - *24th January 2011*

The Department for Regional Development^(a) makes the following Order in exercise of the powers conferred by Articles 37(3), 37(4) and 38(1) of the Road Traffic Regulation (Northern Ireland) Order 1997^(b) and now vested in it^(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 5 to that Order.

The Department has published a Notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as The Roads (Speed Limit) (No. 7) Order (Northern Ireland) 2010 and shall come into operation on 24th January 2011.

Application of speed limits

2. The driving of motor vehicles at a speed exceeding 20 miles per hour on the roads specified in Schedule 1 is prohibited.

Amendment

3. In Article 2 of The Roads (Speed Limit) (No. 4) Order (Northern Ireland) 2010^(d) delete the word “not”.

Revocations

4. The provisions described in Schedule 2 are revoked.

Article 4

Revocations

2. Items 296, 320, 321, 334, 335 and 351 of Schedule 2 to the Roads (Speed Limit) Order (Northern Ireland) 1980**(b)**.
3. Item 186 of Schedule 2 to the Roads (Speed Limit) Order (Northern Ireland) 1986**(c)**.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order—

- (a) applies a speed limit of 20 miles per hour to the roads specified in Schedule 1 (Article 2);
- (b) amends Article 2 of The Roads (Speed Limit) (No. 4) Order (Northern Ireland) 2010 (Article 3); and
- (c) revokes the provisions in Schedule 2 (Article 4).

In relation to the revoked provisions in Schedule 2—

1. The speed limit on Greenvale Park, Kirk Avenue, Princess Drive, Princess Gardens, Princess Terrace, Queens Avenue, Sperrin Drive, Sperrin View and Slemish View, Magherafelt (paragraph 1 of Schedule 2) is now set at 20 miles per hour.
2. The speed limit on Edinburgh Drive, Milburn Close, Milburn Park, Princess Avenue, Queens Avenue and Windsor Crescent, Cookstown (paragraph 2 of Schedule 2) is now set at 20 miles per hour.
3. The speed limit on The Willows, Dungannon (paragraph 3 of Schedule 2) is now set at 20 miles per hour.
