**The Off-Street Parking (Amendment No. 2) Order (Northern Ireland) 2011**

*Made* - - - - *31st March 2011*

*Coming into operation* - *3rd May 2011*

The Department for Regional Development<sup>(a)</sup> makes the following Order in exercise of the powers conferred by Article 13(1) and (2) of the Road Traffic Regulation (Northern Ireland) Order 1997<sup>(b)</sup> and now vested in it<sup>(c)</sup>.

**Citation and commencement**

1. This Order may be cited as The Off-Street Parking (Amendment No. 2) Order (Northern Ireland) 2011 and shall come into operation on 3rd May 2011.

**Revocation**

2. The Off-Street Parking (Amendment) Order (Northern Ireland) 2011<sup>(d)</sup> is revoked.

**Amendment**

3.—(1) The Off-Street Parking Order (Northern Ireland) 2000<sup>(e)</sup> shall be amended in accordance with paragraphs (2) and (3).

## **EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order further amends the Off-Street Parking Order (Northern Ireland) 2000 (“the Order”) by—

- (a) revoking The Off-Street Parking (Amendment) Order (Northern Ireland) 2011;
- (b) substituting a new scale of charges in items of Schedule 1 to the Order as specified in Article 3(2) of this Order; and
- (c) adding new tariffs to Schedule 2 to the Order as specified in Article 3(3) of this Order.

Any person who acts in contravention of any provision of the Order with the exception of Articles 19, 20 (in respect of a stationary vehicle), 21, 22, 23, 24, 25, 26, 27, 28 and 29 shall be liable to a penalty charge (£60) payable in accordance with the Traffic Management (Northern Ireland) Order 2005 and the Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Any person who acts in contravention of Articles 19, 20 (in respect of a moving vehicle), 21, 22, 23, 24, 25, 26, 27, 28 and 29 of the Order shall be guilty of an offence under the Road Traffic Regulation (Northern Ireland) Order 1997 (“the Regulation Order”) and shall be liable on summary conviction to a fine not exceeding level 2 on the standard scale (£500) for each offence, in accordance with the Road Traffic Offenders (Northern Ireland) Order 1996 as amended by the Regulation Order.
