**The Taxis (Enniskillen) (Amendment) Order (Northern Ireland)
2011**

Made - - - - *8th December 2011*

Coming into operation - *30th December 2011*

The Department for Regional Development^(a) makes the following Order in exercise of the powers conferred by Article 27A(1) of the Road Traffic Regulation (Northern Ireland) Order 1997^(b) and now vested in it^(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4A to that Order^(d).

The Department has published a Notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as The Taxis (Enniskillen) (Amendment) Order (Northern Ireland) 2011 and shall come into operation on 30th December 2011.

Amendment

2.—(1) The Taxis (Enniskillen) Order (Northern Ireland) 2011^(e) shall be amended in accordance with paragraph (2).

(2) For the Schedule substitute the Schedule specified in the Schedule to this Order.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order prescribes the precise location which may be used as a stand for taxis in the town of Enniskillen, the maximum number of taxis which may use that stand and the hours available for use.

A penalty charge (£60) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.
