**The Parking and Waiting Restrictions (Omagh) (No. 2) Order
(Amendment) Order (Northern Ireland) 2012**

Made - - - - - *6th February 2012*

Coming into operation - *29th February 2012*

The Department for Regional Development^(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997^(b) and now vested in it^(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a Notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as The Parking and Waiting Restrictions (Omagh) (No. 2) Order (Amendment) Order (Northern Ireland) 2012 and shall come into operation on 29th February 2012.

Amendment

2. The Parking and Waiting Restrictions (Omagh) (No. 2) Order (Northern Ireland) 2010^(d) shall be amended by the addition to Schedule 2 of the items set out in the Schedule to this Order.

SCHEDULE

Article 2

No waiting at any time

All in Omagh

- “4. Holmview Avenue, (north side) – from a point 35 metres west of its junction with Holmview Close, for a distance of 61 metres in an easterly direction.
5. Holmview Avenue, (south side) – from a point 47 metres west of its junction with Holmview Close, for a distance of 32 metres in an easterly direction.
6. Holmview Avenue, (south side) – from a point 15 metres east of its junction with Holmview Close, for a distance of 8 metres in an easterly direction.”

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking and Waiting Restrictions (Omagh) (No. 2) Order (Northern Ireland) 2010 (“the Order”) by the addition to Schedule 2 to that Order of the items relating to Holmview Avenue.

Vehicles are excepted from the prohibitions in certain circumstances.

A penalty charge (£60) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of the Order will in due course be placed on the road.
