**ROAD TRAFFIC AND VEHICLES**

**The Waiting Restrictions (Dungannon) (Amendment) Order  
(Northern Ireland) 2012**

*Made* - - - - - *20th September 2012*

*Coming into operation* - - - - - *12th October 2012*

The Department for Regional Development<sup>(a)</sup> makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997<sup>(b)</sup> and now vested in it<sup>(c)</sup>.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a Notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

**Citation and commencement**

1. This Order may be cited as The Waiting Restrictions (Dungannon) (Amendment) Order (Northern Ireland) 2012 and shall come into operation on 12th October 2012.

**Amendments**

2.—(1) The Waiting Restrictions (Dungannon) Order (Northern Ireland) 2010<sup>(d)</sup> shall be amended in accordance with paragraphs 2 and 3.

(2) To Schedule 1 add the following item—

“3. Dunlea Vale, Dungannon (north-east side) – from a point 15 metres south-east of its junction with Oaks Road, for a distance of 90 metres in a south-easterly direction.”

(3) To Schedule 2 add the following item—

“5. Ballygawley Road, Dungannon (south-west side) – from a point 15 metres north-west of its junction with Linfield Street, for a distance of 121 metres in a north-westerly direction.”

## **EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order amends The Waiting Restrictions (Dungannon) Order (Northern Ireland) 2010 (“the Order”) by the addition to Schedule 1 to that Order of the item in Article 2(2) and by the addition to Schedule 2 to that Order of the item in Article 2(3).

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of the Order will in due course be placed on the roads.
