**The Off-Street Parking (Amendment No. 6) Order (Northern Ireland) 2012**

*Made* - - - - *19th November 2012*

*Coming into operation* - *10th December 2012*

The Department for Regional Development<sup>(a)</sup> makes the following Order in exercise of the powers conferred by Article 13(1) and (2) of the Road Traffic Regulation (Northern Ireland) Order 1997<sup>(b)</sup> and now vested in it<sup>(c)</sup>.

The Department has consulted such persons as the Department considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to that Order.

The Department has published a Notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

**Citation and commencement**

1. This Order may be cited as The Off-Street Parking (Amendment No. 6) Order (Northern Ireland) 2012 and shall come into operation on 10th December 2012.

**Amendment**

2.—(1) The Off-Street Parking Order (Northern Ireland) 2000<sup>(d)</sup> shall be amended in accordance with paragraphs (2) to (4).

(2) Substitute the item specified in the Schedule to this Order for item 295 in Schedule 1 to that Order.

(3) Delete item 294 relating to Lower Water Street, Newry from Schedule 1 to that Order.

(4) For the item relating to “Mill Street, Newry” in Schedule 3 to that Order substitute “Abbey Way (Multi Storey), Newry”.
