**The Parking and Waiting Restrictions (Ballymena)
(Amendment) Order (Northern Ireland) 2012**

Made - - - -

13th December 2012

Coming into operation -

3rd January 2013

The Department for Regional Development(a) makes the following Order in exercise of the powers conferred by Articles 4(1), (2) and (3), 10(4) and 13(1) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the roads specified in Schedule 1 to this Order.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedules 1 and 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a Notice in compliance with paragraphs 1 and 3 of those Schedules.

The Department, in compliance with paragraph 3(4) of Schedule 4 to that Order, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

No objection or other representation has been received.

Citation and commencement

1. This Order may be cited as The Parking and Waiting Restrictions (Ballymena) (Amendment) Order (Northern Ireland) 2012 and shall come into operation on 3rd January 2013.

Amendment

2.—(1) The Parking and Waiting Restrictions (Ballymena) Order (Northern Ireland) 2009(a) shall be amended in accordance with paragraphs (2) to (5).

(2) For Article 12 substitute the following Article —

“Parts of roads on which vehicles must not wait

12. Save as provided in Article 13, a person shall not cause or permit a vehicle to wait—
- (a) on a length of road specified in Schedule 2 or 3 at any time;
 - (b) on a length of road specified in Part I of Schedule 4 during the specified hours;
 - (c) on a length of road specified in Part II of Schedule 4 during the hours between 7.00 a.m. and 7.00 p.m. on Monday to Saturday inclusive;
 - (d) on a length of road specified in Part III of Schedule 4 during the hours between 9.00 a.m. and 5.00 p.m. on Monday to Friday inclusive;
 - (e) on a length of road specified in Part IV of Schedule 4 during the hours between 8.30 a.m. to 9.30 a.m. and between 1.30 p.m. to 3.30 p.m. on Monday to Friday inclusive; or
 - (f) on a length of road specified in Part V of Schedule 4 during the hours between 7.00 a.m. to 9.00 a.m. and between 3.00 p.m. to 5.00 p.m. on Monday to Friday inclusive.”

(3) Part I of Schedule 1 shall be amended by the addition of the items set out in Schedule 1 to this Order.

(4) Schedule 2 shall be amended by the addition of the items set out in Schedule 2 to this Order.

(5) For Schedule 4 substitute the Schedule set out in Schedule 3 to this Order.

SCHEDULE 1

Article 2(3)

- “48. Broughshane Street, Ballymena, (west side) – from a point 54 metres south of its junction with Chapel Roundabout, for a distance of 59 metres.
- 49. Garfield Drive, Ballymena, (south side) – from a point 43 metres east of its junction with Broughshane Street, for a distance of 20 metres.
- 50. Church Street, Ballymena, (north-west side) – from a point 36.5 metres south-west of its junction with Bryan Street, for a distance of 24 metres.”

SCHEDULE 2

Article 2(4)

- “84. Broughshane Street, Ballymena, (west side) – from a point 15 metres south of its junction with Chapel Roundabout to a point 54 metres south of that junction.
- 85. Broughshane Street, Ballymena, (west side) – from a point 113 metres south of its junction with Chapel Roundabout to the entrance to Fairhill Shopping Centre.
- 86. Garfield Drive, Ballymena (south side) – from a point 15 metres east of its junction with Broughshane Street to a point 43 metres east of that junction.
- 87. Garfield Drive, Ballymena, (south side) – from a point 63 metres east of its junction with Broughshane Street to a point 111 metres east of that junction.
- 88. Garfield Drive, Ballymena, (north side) – from a point 15 metres east of its junction with Broughshane Street to a point 111 metres east of that junction.
- 89. Galgorm Industrial Estate, Galgorm, Ballymena, (north-west side) – from a point 432 metres south-east of its junction with Fenaghy Road for a distance of 20 metres in a north-easterly direction.
- 90. Galgorm Industrial Estate, Galgorm, Ballymena, (south-west and south-east sides) – from a point 434 metres south-east of its junction with Fenaghy Road for a distance of 60 metres in a south-easterly direction and then a north-easterly direction.”

Article 12

No waiting — Working Day Restrictions

PART I

Monday to Saturday 9.00 a.m. to 5.00 p.m.

1. Albert Place, Ballymena, (west side) – from a point 45 metres south of its junction with Fountain Place, for a distance of 85 metres.
2. Fountain Place, Ballymena, (north side) – from a point 22 metres east of its junction with Ballymoney Road, for a distance of 50 metres.
3. Fountain Place, Ballymena, (north side) – from a point 15 metres west of its junction with Duke Street, for a distance of 10 metres.
4. High Street, Ballymena, (east side) – from a point 15 metres south of its junction with John Street, for a distance of 52 metres.
5. High Street, Ballymena, (east side) – from a point 90 metres south of its junction with John Street, for a distance of 10 metres.
6. Mount Street, Ballymena, (north side) – from a point 30 metres east of its junction with Ballymoney Road for a distance 62 metres.
7. Mount Street, Ballymena, (north side) – from a point 10 metres west of its junction with Duke Street, for a distance of 8 metres.

PART II

Monday to Saturday 7.00 a.m. to 7.00 p.m.

1. Galgorm Industrial Estate, Galgorm, Ballymena, (north-west side) – from a point 64 metres north-east of its junction with Fenaghy Road, for a distance of 66 metres.
2. Galgorm Industrial Estate, Galgorm, Ballymena, (south-east side) – from a point 63 metres north-east of its junction with Fenaghy Road, for a distance of 30 metres.

PART III

Monday to Friday 9.00 a.m. to 5.00 p.m.

1. Old Mill Park, Cullybackey, Ballymena, (north-west side) – from a point 15 metres south-west of its junction with Main Street for a distance of 80 metres in a south-westerly direction.
2. Old Mill Park, Cullybackey, Ballymena, (south-east side) – from a point 15 metres south-west of its junction with Main Street for a distance of 80 metres in a south-westerly direction.

PART IV

Monday to Friday 8.30 a.m. to 9.30 a.m. and 1.30 p.m. to 3.30 p.m.

Fairfield, Gracehill, Ballymena, (both sides) – from a point 15 metres north-west of its junction with Galgorm Road, for a distance of 25 metres.

PART V

Monday to Friday 7.00 a.m. to 9.00 a.m. and 3.00 p.m. to 5.00 p.m.

1. Corbally Road, Galgorm, Ballymena, (south side) – from a point 15 metres west of its junction with Fenaghy Road, for a distance of 83 metres.
2. Corbally Road, Galgorm, Ballymena, (north side) – from a point 15 metres west of its junction with Fenaghy Road for a distance of 83 metres.
3. Fenaghy Road Service Road, Galgorm, Ballymena, (all sides) – from a point 15 metres south-west of its junction with Fenaghy Road (north side of entrance) to a point 15 metres south-west of its junction with Fenaghy Road (south side of entrance)."

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking and Waiting Restrictions (Ballymena) Order (Northern Ireland) 2009—

- (a) by adding to Part I of Schedule 1 to that Order the items relating to Broughshane Street, Garfield Drive and Church Street, Ballymena as set out in Article 2(3) and Schedule 1 to this Order;
- (b) by adding to Schedule 2 to that Order the items relating to Broughshane Street, Garfield Drive and Galgorm Industrial Estate as set out in Article 2(4) and Schedule 2 to this Order; and
- (c) by the substitution for Schedule 4 of the Schedule set out in Schedule 3 to this Order. The effect of the amendments is to add the prohibition on vehicles waiting on the lengths of Corbally Road and Fenaghy Road Service Road, Galgorm, Ballymena as set out in Part V of Schedule 4 (as so substituted) during the hours and on the days referred to therein.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of the Order will in due course be placed on the roads.
