The Department of Agriculture and Rural Development, makes the following Order in exercise of the powers conferred by section 39(1) of the Forestry Act (Northern Ireland) 2010(1).

Citation and interpretation

1.—(1) This Order may be cited as the Forestry (2010 Act) (Commencement No. 2) Order (Northern Ireland) 2013.

(2) In this Order “the Act” means the Forestry Act (Northern Ireland) 2010.
