**The Taxis (2008 Act) (Commencement
No. 3) Order (Northern Ireland) 2014**

Made - - - - 23rd September
2014

The Department of the Environment makes the following Order in exercise of the powers conferred by section 59 of the Taxis Act (Northern Ireland) 2008⁽¹⁾.

Citation and interpretation

1. (1) This Order may be cited as the Taxis (2008 Act) (Commencement No.3) Order (Northern Ireland) 2014.

(2) In this Order “the Act” means the Taxis Act (Northern Ireland) 2008.

Appointed day

2. (1) The day appointed for the coming into operation of the provisions of the Act specified in Part 1 of the Schedule for the purpose only of making regulations, is 24th September 2014.

(2) The day appointed for the coming into operation of the provisions of the Act specified in Part 2 of the Schedule, is 31st October 2014.
