The Department of Finance and Personnel makes the following Order in exercise of the powers conferred by section 19(1) of the Rates (Amendment) Act (Northern Ireland) 2009(a).

**Citation and interpretation**

**1.**—(1) This Order may be cited as the Rates (Amendment) (2009 Act) (Commencement No. 3) Order (Northern Ireland) 2014.

(2) In this Order “the 2009 Act” means the Rates (Amendment) Act (Northern Ireland) 2009.

**Appointed day**

**2.** 1st April 2015 is the day appointed for the coming into operation of the provisions of the 2009 Act listed in the Schedule.
