ROAD TRAFFIC AND VEHICLES

The Parking Places (Disabled Persons' Vehicles) (Amendment No. 2) Order (Northern Ireland) 2016

Made - - - - 21st September 2016

Coming into operation - 12th October 2016

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1) and (16) of, and paragraph 5 of Schedule 4 to, the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the roads specified in the Schedule.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

Three objections have been received and duly considered and no other representations have been received.

Citation and commencement

1. This Order may be cited as The Parking Places (Disabled Persons' Vehicles) (Amendment No. 2) Order (Northern Ireland) 2016 and shall come into operation on 12th October 2016.

 - 761. The Square, Comber (north-east side) from a point 38 metres south-east of its junction with Bridge Street, for a distance of 4.4 metres in a south-easterly direction.
 - 762. The Square, Comber (north-west side) from a point 16 metres north-east of its junction with Castle Street, for a distance of 9.7 metres in a north-easterly direction."

This Order amends The Parking Places (Disabled Persons' Vehicles) Order (Northern Ireland) 2016 by the introduction of parking places with unlimited waiting on the lengths of the roads specified in the Schedule, the removal of the parking places referred to in Article 2(2) and the amendment to the descriptions of the parking places referred to in Article 2(3).
