**The Bus Lanes Order (Amendment) Order (Northern Ireland)  
2016**

*Made* - - - - - *30th September 2016*

*Coming into operation* - *24th October 2016*

The Department for Infrastructure<sup>(a)</sup> makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997<sup>(b)</sup> and now vested in it<sup>(c)</sup>.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

**Citation and commencement**

1. This Order may be cited as The Bus Lanes Order (Amendment) Order (Northern Ireland) 2016 and shall come into operation on 24th October 2016.

**Amendment**

2. Schedule 1 to the Bus Lanes Order (Northern Ireland) 2002<sup>(d)</sup> is amended by—
- (a) the deletion of item no. 31 relating to Shore Road, Newtownabbey; and
  - (b) the substitution for item no. 32 relating to Station Road, Newtownabbey of the following item—
