**The Derriaghy Road, Lisburn (Abandonment) Order (Northern Ireland) 2016**

*Made* - - - - - *5th October 2016*

*Coming into operation* - *30th November 2016*

The Department for Infrastructure<sup>(a)</sup> makes the following Order in exercise of the powers conferred by Article 68(1), (3) and (5) of the Roads (Northern Ireland) Order 1993<sup>(b)</sup> and now vested in it<sup>(c)</sup>.

The Department in accordance with Article 68(4) of that Order proposes to abandon the area of road described in the Schedule as it is not necessary.

Notice has been published, served and displayed in compliance with paragraphs 1, 2 and 3 of Schedule 8 to that Order.

No objection has been received.

**Citation and commencement**

1. This Order may be cited as The Derriaghy Road, Lisburn (Abandonment) Order (Northern Ireland) 2016 and shall come into operation on 30th November 2016.

**Application**

2. The area of road described in the Schedule is abandoned.

3.—(1) All existing cables, wires, mains, pipes or other apparatus placed along, across, over or under the abandoned area of road shall be retained.

(2) All existing rights as to the use or maintenance of such cables, wires, mains, pipes or other apparatus shall be preserved.

**Revocation**

4. The Derriaghy Road, Lisburn (Stopping-Up) Order (Northern Ireland) 2005<sup>(d)</sup> is revoked.

## SCHEDULE

Article 2

### AREA OF ROAD TO BE ABANDONED

An area of 744.5 square metres of road at the former Derriaghy Road, Lisburn from a point 66.55 metres north-east of its junction with Pond Park Road extending for 99.81 metres in a north-easterly direction, more particularly delineated and shown cross-hatched and coloured blue on Map No. IN1/16/9830.

A copy of the map has been deposited at the Department's Headquarters, Room 301, Clarence Court, 10-18 Adelaide Street, Belfast and at TransportNI, Lands Section, Eastern Division, Hydebank, 4 Hospital Road, Belfast.
