**RATES**

**The Rates (Automatic Telling Machines) (Designation of Rural Areas) Order (Northern Ireland) 2016**

*Made* - - - - *24th February 2016*  
*Coming into operation* *1st April 2016*

The Department of Finance and Personnel makes the following Order in exercise of the powers conferred by Article 42(1G) of the Rates (Northern Ireland) Order 1977<sup>(1)</sup>.

**Citation and commencement**

**1.** This Order may be cited as the Rates (Automatic Telling Machines) (Designation of Rural Areas) Order (Northern Ireland) 2016 and shall come into operation on 1st April 2016.

**Designation of rural areas**

**2.** Wards as set out in the Schedule are designated as rural areas for the purpose of Article 42 (1F) of the Rates (Northern Ireland) Order 1977.

**Revocation**

**3.** The Rates (Automatic Telling Machines) (Designation of Rural Areas) Order (Northern Ireland) 2006<sup>(2)</sup> is revoked.
