**The Control of Traffic (Cairnshill Drive, Belfast) Order  
(Northern Ireland) 2017**

*Made* - - - - - *30th June 2017*

*Coming into operation* - *21st July 2017*

The Department for Infrastructure<sup>(a)</sup> makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997<sup>(b)</sup> and now vested in it<sup>(c)</sup>.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

**Citation and commencement**

1. This Order may be cited as The Control of Traffic (Cairnshill Drive, Belfast) Order (Northern Ireland) 2017 and shall come into operation on 21st July 2017.

**Amendments**

2. The Parking and Waiting Restrictions (Belfast) Order (Northern Ireland) 2016<sup>(d)</sup> is amended by the addition to Part 2 of Schedule 2 of the following item—

“11. Cairnshill Drive (north-east side and east side) – from a point 15 metres south-west of its junction with Cairnshill Park for a distance of 50 metres in a north-westerly direction (40 metres) and then a northerly direction (10 metres).”

3. The Prohibition of Waiting (Schools) Order (Northern Ireland) 2015<sup>(e)</sup> is amended by the addition to Schedule 2 of the following item—

**EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order amends The Parking and Waiting Restrictions (Belfast) Order (Northern Ireland) 2016 and The Prohibition of Waiting (Schools) Order (Northern Ireland) 2015 (“the Orders”) by the addition of a no waiting at any time restriction on the length of road specified in Article 2 and a prohibition of waiting on the length of road specified in Article 3. Vehicles are excepted from the restriction and prohibition in certain circumstances.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Orders in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of the Order will in due course be placed on the road.
