ROAD TRAFFIC AND VEHICLES

The Parking Places (Disabled Persons' Vehicles) (Amendment No. 2) Order (Northern Ireland) 2017

Made - - - - 30th June 2017

Coming into operation - 21st July 2017

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1) and (16) of, and paragraph 5 of Schedule 4 to, the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the roads specified in the Schedules.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

One objection was received and duly considered and no other representations were received.

The Department has modified the draft Order.

Citation and commencement

1. This Order may be cited as The Parking Places (Disabled Persons' Vehicles) (Amendment No. 2) Order (Northern Ireland) 2017 and shall come into operation on 21st July 2017.

"2386.	Donegore Drive, Antrim (west side) – from a point 25 metres north of its junction with Kilbride Gardens, for a distance of 5.5 metres in a northerly direction.
2387.	Heather Close, Antrim (west side) – from a point 55 metres north-west of its junction with Bracken Avenue, for a distance of 5.5 metres in a westerly direction.
2388.	Cathedral Road, Armagh (north side) – from a point 83 metres east of its junction with Desart Lane Lower, for a distance of 6 metres in an easterly direction.
2389.	Cathedral Road, Armagh (north side) – from a point 83 metres west of its junction with Edward Street, for a distance of 6 metres in a westerly direction.
2390.	Drumbreda Avenue, Armagh (north-west side of western cul-de-sac, to the rear of No. 22 Drumbreda Gardens) – from a point 156 metres north-east of its junction with Drumbreda Walk, for a distance of 3 metres in a north-westerly direction.
2391.	Tievedoo Park, Attical (north-west side) – from a point 31 metres west of its junction with Aughrim Road, for a distance of 6 metres in a westerly direction.

2395.	North Parade, Belfast (north side) – from a point 113 metres east of its junction with Cross Parade, for a distance of 5.5 metres in an easterly direction.
2396.	Old Bakers Court, Belfast (north-west side) (in a lay-by in front of Firmount Building) – from a point 35 metres north-east of its junction with Ardenlee Crescent, for a distance of 6.6 metres in a north-easterly direction.
2397.	The Gardens, Bessbrook (west side) – from a point 41 metres north of its junction with Church Road, for a distance of 6 metres in a northerly direction.
2398.	Cambrook Estate, Camlough (north-west side of first cul-de-sac) – from a point 58 metres south-west of its junction with Cambrook Estate Main Road, for a distance of 3 metres in a south-westerly direction.
2399.	Unity Street, Carrickfergus (north side) – from a point 8 metres south-east of its junction with Thomas Street for a distance of 5.5 metres in a south-easterly direction.
2400.	Cherryhill Park, Dundonald (east side) – from a point 26 metres north of its junction with Cherryhill Gardens, for a distance of 5.5 metres in a northerly direction.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking Places (Disabled Persons' Vehicles) Order (Northern Ireland) 2017 by the introduction of parking places with unlimited waiting on the lengths of the roads specified in Schedule 1, the introduction of parking places with limited waiting on the lengths of road specified in Schedule 2 and the removal of parking places referred to in Articles 2(2)(a) and 2(3)(a).
