### ROAD TRAFFIC AND VEHICLES

#### The Roads (Speed Limit) (No. 3) Order (Northern Ireland) 2017

*Made* - - - - - *23rd August 2017*

*Coming into operation* - - - - - *18th September 2017*

The Department for Infrastructure<sup>(a)</sup> makes the following Order in exercise of the powers conferred by Articles 37(3), 37(4) and 38(1)(a) of the Road Traffic Regulation (Northern Ireland) Order 1997<sup>(b)</sup> and now vested in it<sup>(c)</sup>.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 5 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

#### **Citation and commencement**

1. This Order may be cited as The Roads (Speed Limit) (No. 3) Order (Northern Ireland) 2017 and shall come into operation on 18th September 2017.

#### **Speed restriction on certain roads**

2. The Department directs that the length of road specified in Schedule 1 shall be a restricted road.

#### **Application of speed limits**

3. The driving of motor vehicles at a speed exceeding 20 miles per hour on the roads specified in Schedule 2 is prohibited.

4. The driving of motor vehicles at a speed exceeding 40 miles per hour on the length of road specified in Schedule 3 is prohibited.

#### **Revocations**

5. The provisions described in Schedule 4 are revoked.

## SCHEDULE 1

Article 2

### Restricted length of road

Fenaghy Road, Route C56, Cullybackey, from its junction with Main Street, Route B62, to a point 685 metres south-east of that junction.

## SCHEDULE 2

Article 3

### Roads subject to a speed limit of 20 miles per hour

1. Cloneen, Unclassified No. 7506, Dungannon.
2. Cloneen Avenue, Unclassified No. 7506, Dungannon.

## SCHEDULE 3

Article 4

### Length of road subject to a speed limit of 40 miles per hour

Mallusk Road, Route B95, Mallusk, Newtownabbey, from its junction with Hyde Park Road, Unclassified No. 10, to its junction with Hightown Road, Route B95.

### Revocations

## **EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order—

- (a) makes the length of road specified in Schedule 1 a restricted road;
- (b) applies a speed limit of 20 miles per hour to the roads specified in Schedule 2;
- (c) applies a speed limit of 40 miles per hour to the length of road specified in Schedule 3;  
and
- (d) revokes the provisions in Schedule 4.

In relation to the revoked provisions in Schedule 4—

- 1.** The speed limit on the length of Fenaghy Road, Cullybackey (paragraph 1 of Schedule 4) is now a longer length of 30 miles per hour (restricted road).
- 2.** The speed limit on the length of Mallusk Road, Mallusk, Newtownbbey (paragraph 2 of Schedule 4) is now partly 30 miles per hour (restricted by street lighting) and partly set at 40 miles per hour.
