ROAD TRAFFIC AND VEHICLES

The Parking Places (Disabled Persons' Vehicles) (Amendment No. 4) Order (Northern Ireland) 2017

Made - - - - 11th September 2017

Coming into operation - 2nd October 2017

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1) and (16) of, and paragraph 5 of Schedule 4 to, the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the roads specified in the Schedules.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

Six objections have been received and duly considered and no other representations have been received.

The Department has modified the draft Order.

Citation and commencement

1. This Order may be cited as The Parking Places (Disabled Persons' Vehicles) (Amendment No. 4) Order (Northern Ireland) 2017 and shall come into operation on 2nd October 2017.

- **2.**—(1) The Parking Places (Disabled Persons' Vehicles) Order (Northern Ireland) 2016(**a**) is amended in accordance with paragraphs (2) and (3).
 - (2) In Schedule 1—
 - (a) Delete the following—
 - (i) item no. 387 relating to Carncaver Road, Belfast;
 - (ii) item no. 540 relating to Redcar Street, Belfast; and
 - (iii) item no. 791 relating to Orritor Street, Cookstown.
 - (b) For item no. 1044 substitute the following
 - "1044. Irish Street, Dungannon (north side) from a point 27 metres east of its junction with Greers Road, for a distance of 7 metres in an easterly direction."
 - (c) For item no. 1452 substitute the following
 - "1452. Albert Avenue, Lurgan (south-east side) from a point 68 metres south-west of its junction with Albert Street, for a distance of 6 metres in a south-westerly direction."
 - (d) For item no. 1575 substitute the following
 - "1575. Central Promenade, Newcastle (west side) from a point 24.5 metres south of its junction with Post Office Lane, for a distance of 6 metres in a southerly direction.
 - (e) Add the items set out in Schedule 1 to this Order.
 - (3) In Schedule 6 add the item set out in Schedule 2 to this Order.

"20. Belmont Road, Belfast (north side in a lay-by) – from a point 15.1 metres east of its junction with Holywood Road, for a distance of 6.5 metres in an easterly direction."

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking Places (Disabled Persons' Vehicles) Order (Northern Ireland) 2016.

The amendments provide for the introduction of parking places with unlimited waiting on the lengths of the road specified in Schedule 1 and a parking place with waiting limited to 2 hours on Monday to Saturday between 8.00 a.m. and 6.00 p.m. specified in Schedule 2, the amendment of the items specified in Article 2(2)(b), (c) and (d) and the removal of the parking places referred to in Article 2(2)(a).
