**The Urban Clearways (Amendment) Order (Northern Ireland)
2017**

Made - - - - - *19th September 2017*

Coming into operation - - - - - *9th October 2017*

The Department for Infrastructure^(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997^(b) and now vested in it^(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

One written objection has been received and subsequently withdrawn and no other representation has been received.

Citation and commencement

1. This Order may be cited as The Urban Clearways (Amendment) Order (Northern Ireland) 2017 and shall come into operation on 9th October 2017.

Amendments

2.—(1) Schedule 1 to The Urban Clearways Order (Northern Ireland) 2016^(d) is amended in accordance with paragraphs (2) and (3).

(2) Delete item no. 23 relating to Antrim Road, Belfast and item no. 119 relating to Sandown Road, Belfast.

(3) Add the items specified in the Schedule to this Order.

“189.	Antrim Road, Belfast – from its junction with Carlisle Circus to its junction with Cliftonville Road – both sides.	8.00 a.m. to 9.30 a.m. and 4.30 p.m. to 6.00 p.m.	Monday to Friday inclusive
190.	Antrim Road, Belfast (east side) – from the mid-point of Bellevue Bridge to its junction with Cliftonville Road – citybound direction.	8.00 a.m. to 9.30 a.m.	Monday to Friday inclusive
191.	Antrim Road, Belfast (west side) – from its junction with Cliftonville Road to the mid-point of Bellevue Bridge – countrybound direction.	4.30 p.m. to 6.00 p.m.	Monday to Friday inclusive”

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Urban Clearways Order (Northern Ireland) 2016 (“the Order”) by—

- (a) deleting the item relating to Sandown Road, Belfast;
- (b) deleting the item relating to Antrim Road, Belfast and creating a shorter length of urban clearway on Monday to Friday between the hours 8.00 a.m. to 9.30 a.m. and 4.30 p.m. to 6.00 p.m. in both directions; and
- (c) creating lengths of urban clearway from Monday to Friday between the hours 8.00 a.m. to 9.30 a.m. in the citybound direction only and between 4.30 p.m. to 6.00 p.m. in the countrybound direction only on a length of Antrim Road, Belfast.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of the Order will in due course be placed on the road.
