ROAD TRAFFIC AND VEHICLES

**The Parking and Waiting Restrictions (Strabane) (Amendment)
Order (Northern Ireland) 2019**

Made - - - - - *19th July 2019*

Coming into operation - *12th August 2019*

The Department for Infrastructure^(a) makes the following Order in exercise of the powers conferred by Articles 4(1), (2) and (3), 10(4) and 13(1) of the Road Traffic Regulation (Northern Ireland) Order 1997^(b) and now vested in it^(c).

It appears to the Department to be necessary to provide a suitable parking place for vehicles on the length of the road specified in Article 2(2).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedules 1 and 4 the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of those Schedules.

The Department in compliance with paragraph 3(4) of Schedule 4 to that Order, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking place the particulars specified in paragraph 3(2) of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as The Parking and Waiting Restrictions (Strabane) (Amendment) Order (Northern Ireland) 2019 and shall come into operation on 12th August 2019.

Amendments

2.—(1) The Parking and Waiting Restrictions (Strabane) Order (Northern Ireland) 2015^(d) is amended in accordance with paragraphs (2) to (4).

(2) In Schedule 1 after item 15 add the following item—

- “16. Park Road (west side) – from a point 34 metres north of its junction with Railway Street for a distance of 18 metres in a northerly direction.”

(3) In Part 1 of Schedule 2 after item 11 add the following items—

- “12. Melvin Road (north-east side) – from a point 15 metres south-east of its junction with Bridge Street for a distance of 125 metres in a south-easterly direction.
13. Park Road (west side) – from a point 15 metres north of its junction with Railway Street for a distance of 19 metres in a northerly direction.”

(4) For Part 3 of Schedule 2 substitute the following—

“PART 3

No Waiting Monday to Friday 8.00 a.m. to 5.30 p.m. — Loading and unloading permitted

1. Park Road (west side) – from a point 52 metres north of its junction with Railway Street for a distance of 138 metres in a northerly direction.
2. Urney Road, Strabane (south side) – from a point 125 metres east of its junction with Owenreagh Drive for a distance of 84 metres in an easterly direction.”

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking and Waiting Restrictions (Strabane) Order (Northern Ireland) 2015 (“the Order”) by the addition to Schedule 1 of the item specified in Article 2(2) and the addition to Part 1 of Schedule 2 of the items specified in Article 2(3) to this Order. The Order also adds to Part 3 of Schedule 2 the item related to Park Road specified in Article 2(4) to this Order.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of this Order will in due course be placed on the roads.
