The Central Reservations on the A1 Dromore By-Pass, Dromore and the A1 Dromore Road, Hillsborough (Stopping-Up) Order (Northern Ireland) 2019

Made - - - - 9th September 2019

Coming into operation - 7th October 2019

The Department for Infrastructure(a) makes the following Order in exercise of its powers conferred by Article 68(1), (3) and (5) of the Roads (Northern Ireland) Order 1993(b) and now vested in it(c).

The Department in accordance with Article 68(4) of that Order is of the opinion that the lengths of the roads described in the Schedule are not necessary for road traffic.

Notice has been published, served and displayed in compliance with paragraphs 1, 2 and 3 of Schedule 8 to that Order.

One objection has been received and duly considered.

Citation and commencement

1. This Order may be cited as The Central Reservations on the A1 Dromore By-Pass, Dromore and the A1 Dromore Road, Hillsborough (Stopping-Up) Order (Northern Ireland) 2019 and shall come into operation on 7th October 2019.

Application

- **2.**—(1) The lengths of road described in the Schedule shall be stopped-up to road traffic at the lines specified therein.
- (2) The Department shall carry out such works as it considers necessary to prevent or restrict to such extent as the Department thinks fit, access to the lengths of road described in the Schedule by road traffic.
- **3.**—(1) All existing cables, wires, mains, pipes or other apparatus placed along, across, over or under the roads shall be retained.
- (2) All existing rights as to the use or maintenance of such cables, wires, mains, pipes or other apparatus shall be preserved.

Article 2

ROADS TO BE STOPPED UP TO ROAD TRAFFIC

- **1.** The north-west side of the central reservation of the A1 Dromore By-Pass, Dromore at a line from a point 389 metres north-east of the centre of the Banbridge Road over bridge, for a distance of 7 metres in a north-easterly direction, more particularly delineated and marked A-B on map number IN1/18/761715.
- **2.** The south-east side of the central reservation of the A1 Dromore By-Pass, Dromore at a line from a point 396 metres north-east of the centre of the Banbridge Road over bridge for a distance of 7 metres in a south-westerly direction, more particularly delineated and marked C-D on Map number IN1/18/761715.
- **3.** The north-west side of the central reservation of the A1 Dromore Road, Hillsborough at a line from a point 719 metres south-west of the centre of the Dromore Road over bridge for a distance of 6 metres in a north-easterly direction, more particularly delineated and marked E-F on Map number IN1/18/761724.
- **4.** The south-east side of the central reservation of the A1 Dromore Road, Hillsborough at a line from a point 717 metres south-west of the centre of the Dromore Road over bridge for a distance of 6 metres in a south-westerly direction more particularly delineated and marked G-H on Map number IN1/18/761724.
