ROAD TRAFFIC AND VEHICLES

The Roads (Speed Limit) (No. 3) Order (Northern Ireland) 2020

Made - - - - *17th November 2020*

Coming into operation - *8th December 2020*

The Department for Infrastructure^(a) makes the following Order in exercise of the powers conferred by Articles 37(3), 37(4) and 38(1)(a) of the Road Traffic Regulation (Northern Ireland) Order 1997^(b) and now vested in it^(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 5 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as The Roads (Speed Limit) (No. 3) Order (Northern Ireland) 2020 and shall come into operation on 8th December 2020.

Application of speed limits

2. The driving of motor vehicles at a speed exceeding 20 miles per hour on the roads specified in Schedule 1 is prohibited.

3. The driving of motor vehicles at a speed exceeding 40 miles per hour on the lengths of road specified in Schedule 2 is prohibited.

4. The driving of motor vehicles at a speed exceeding 50 miles per hour on the length of road specified in Schedule 3 is prohibited.

Revocations

5. The provisions described in Schedule 4 are revoked.

SCHEDULE 1

Article 2

Roads subject to a speed limit of 20 miles per hour

1. Centenary Park, Unclassified No. 3005, Omagh.
2. Strule Park, Unclassified No. 3005, Omagh.

SCHEDULE 2

Article 3

Lengths of road subject to a speed limit of 40 miles per hour

1. Old Manse Road, Route A50, Banbridge, from its junction with the A1 Dual Carriageway to its junction with the Castlewellan Road, Route A50.
2. Derryvale Road, Route C636, Newmills, Dungannon, from its junction with Farlough Road, Route C638, to a point 537 metres north-east of that junction.
3. Farlough Road, Route C638, Newmills, Dungannon, from a point 520 metres north-west of its junction with Derryvale Road, Route C636, to a point 373 metres south and then south-east of that junction.

SCHEDULE 3

Article 4

Length of road subject to a speed limit of 50 miles per hour

Derrygonnelly Road, Route B81, Enniskillen, from its junction with Lough Shore Road, Route A46, to a point 100 metres west of its junction with Lover's Lane, Unclassified No. 6528.

SCHEDULE 4

Article 5

Revocations

1. The item referred to as The Knockloughrim–Gulladuff Road, Class III No. C550. Co. Londonderry, from its junction with the Maghera-Toome Road, Class I No. A6, to a point approximately 343 yards north of this junction in the second Schedule to the Speed Limits Order (Northern Ireland) 1956**(a)**.
2. Items 53 and 217 of Schedule 1 to the Roads (Speed Limit) Order (Northern Ireland) 1990**(b)**.
3. Item 194 of the Schedule to the Roads (Speed Limit) (No. 9) Order (Northern Ireland) 1998**(c)**.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order—

- (a) applies a speed limit of 20 miles per hour to the roads specified in Schedule 1;
- (b) applies a speed limit of 40 miles per hour to the lengths of road specified in Schedule 2;
- (c) applies a speed limit of 50 miles per hour to the length of road specified in Schedule 3;
and
- (d) revokes the provisions in Schedule 4.

In relation to the revoked provisions in Schedule 4—

1. The speed limit on the length of the Knockloughrim – Gulladuff Road, now known as Quarry Road, Knockloughrim, (paragraph 1 of Schedule 4) is no longer needed as the speed limit has been superseded.

2. The speed limits on the lengths of Centenary Park and Strule Park, Omagh (paragraph 2 of Schedule 4) are now set at 20 miles per hour.

3. The speed limit on the length of Monea Road, Enniskillen, now known as Derrygonnelly Road, Enniskillen, (paragraph 3 of Schedule 4) is now included in a longer length of road set at 50 miles per hour.

4. The speed limit on Old Manse Road, Banbridge (paragraph 4 of Schedule 4) is now set at 40 miles per hour.

5. The speed limit on the length of Mossvale Road, Dromore (paragraph 5 of Schedule 4) is now included in a longer length of 30 miles per hour (restricted by street lighting).
