**The Parking Places on Roads and Waiting Restrictions (Newry)
(Amendment) Order (Northern Ireland) 2022**

Made - - - - - *26th October 2022*

Coming into operation - *17th November 2022*

The Department for Infrastructure^(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of, and paragraph 5 of Schedule 1 to, the Road Traffic Regulation (Northern Ireland) Order 1997^(b) and now vested in it ^(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order. The Department has published a notice in compliance with paragraphs 1 and 3 of those Schedules.

One objection has been received and duly considered and no other representations have been received.

The Department has modified the draft Order.

Citation and commencement

1. This Order may be cited as the Parking Places on Roads and Waiting Restrictions (Newry) (Amendment) Order (Northern Ireland) 2022 and shall come into operation on 17th November 2022.

Amendments

2.—(1) The Parking Places on Roads and Waiting Restrictions (Newry) Order (Northern Ireland) 2015^(d) is amended in accordance with paragraphs 2 and 3.

(2) In Part 1 of Schedule 2 add the following items—

- “15. Albert Basin (east side) – from a point 383 metres south of its junction with Bridge Street for a distance of 260 metres in a southerly direction.
- 16. Albert Basin (west side) – from a point 460 metres south of its junction with Bridge

- Street for a distance of 119 metres in a southerly direction.
17. Albert Basin (west side) – from a point 590 metres south of its junction with Bridge Street for a distance of 52 metres in a southerly direction.
 18. Hospital Road (north-east side) – from its junction with Carnagat Road for a distance of 179 metres in a south-easterly direction.
 19. Hospital Road (north-east side) – from a point 188 metres south-east of its junction with Carnagat Road for a distance of 62 metres in a south-easterly direction.
 20. Hospital Road (south-west side) – from a point 136 metres south-east of its junction with Carnagat Road for a distance of 148 metres in a south-easterly direction.
 21. Hospital Road (south-west side) – from a point 286 metres south-east of its junction with Carnagat Road for a distance of 67 metres in a south-easterly direction.”

(3) In Part 3 of Schedule 2 delete the item relating to Hospital Road.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking Places on Roads and Waiting Restrictions (Newry) Order (Northern Ireland) 2015 (“the Order”) by the addition to Part 1 of Schedule 2 of the items relating to Albert Basin and Hospital Road, Newry specified in Article 2.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of this Order will in due course be placed on the roads.
