**The Coshquin Road, Londonderry (Abandonment) Order
(Northern Ireland) 2022**

Made - - - - - *26th October 2022*

Coming into operation - *5th December 2022*

The Department for Infrastructure^(a) makes the following Order in exercise of the powers conferred by Article 68(1) and (5) of the Roads (Northern Ireland) Order 1993^(b) and now vested in it^(c).

The Department in accordance with Article 68(4) of that Order proposes on the completion of works providing alternative facilities for road traffic to abandon the areas of road described in the Schedule.

Notice has been published, served and displayed in compliance with paragraphs 1, 2 and 3 of Schedule 8 to that Order.

No objection has been received.

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Coshquin Road, Londonderry (Abandonment) Order (Northern Ireland) 2022 and shall come into operation on 5th December 2022.

(2) In this Order “the developer” means Braidwater Limited whose registered office is situated at 25F Longfield Road, Eglinton, Co. Londonderry, BT47 3PY.

Application

2. The developer shall carry out such works as the Department considers necessary for the provision of alternative facilities for road traffic and on completion of the works the areas of road described in the Schedule shall be abandoned.

3.—(1) All existing cables, wires, mains, pipes or other apparatus placed along, across, over or under the abandoned areas of road shall be removed.

(2) All existing rights as to the use or maintenance of such cables, wires, mains, pipes or other apparatus shall be extinguished.

SCHEDULE

Article 2

AREAS OF ROAD TO BE ABANDONED

Four areas of Coshquin Road, Londonderry totalling 1,352 square metres consisting of —

- (a) 467 square metres of carriageway extending from its junction with Whitehouse Road for a distance of 85 metres in a north-westerly direction;
- (b) 308 square metres of carriageway extending from a point 148 metres north-west of its junction with Whitehouse Road for a distance of 52 metres in a north-westerly direction;
- (c) 232 square metres of carriageway extending from a point 351 metres north-west of its junction with Whitehouse Road for a distance of 39 metres in a north-westerly direction;
- (d) 345 square metres of carriageway extending from a point 442 metres north-west of its junction with Whitehouse Road for a distance of 60 metres in a north-westerly direction;

more particularly delineated and shown crosshatched and coloured red on map IN1/22/150280.
