## ROAD TRAFFIC AND VEHICLES

The Parking Places (Disabled Persons' Vehicles) (Amendment No. 9) Order (Northern Ireland) 2023

Made - - - - 5th December 2023

Coming into operation - 28th December 2023

The Department for Infrastructure(**a**) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1) and (16) of, and paragraph 5 of Schedule 4 to, the Road Traffic Regulation (Northern Ireland) Order 1997(**b**) and now vested in it(**c**).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the roads specified in the Schedule.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

Six objections have been received and no other representations have been received.

The Department has modified the draft Order.

#### Citation and commencement

**1.** This Order may be cited as the Parking Places (Disabled Persons' Vehicles) (Amendment No. 9) Order (Northern Ireland) 2023 and shall come into operation on 28th December 2023.

# **Unlimited Waiting**

"3157.	Central Street, Bangor (north-west side) – from a point 48 metres north-east of its junction with Central Avenue for a distance of 5.5 metres in a north-easterly direction
3158.	Coombe Hill Park, Belfast (south-west side) – from a point 18 metres north-west of its junction with Joanmount Park for a distance of 5.5 metres in a north-westerly direction.
3159.	Disraeli Street, Belfast (south-east side) – from a point 58 metres north-east of its junction with Rathlin Street for a distance of 5.5 metres in a north-easterly direction.
3160.	Donegall Avenue, Belfast (north-west side) – from a point 46 metres south-west of its junction with Frenchpark Street for a distance of 5.5 metres in south-westerly direction.
3161.	Fernwood Street, Belfast (east side) – from a point 25 metres south of its junction with Blackwood Street for a distance of 5.5 metres in a southerly direction.
3162.	Glantane Drive, Belfast (east side) – from a point 35 metres south of its junction with Glandore Gardens for a distance of 5.5 metres in a southerly direction.
3163.	Ligoniel Road, Belfast (south-west side) – from a point 29 metres north-west of its junction with Leginn Street for a distance of 6 metres in a north-westerly direction.
3164.	Knocknagoney Avenue, Belfast (south side) – from a point 85 metres west of its junction with Knocknagoney Gardens for a distance of 5.5 metres in a westerly direction.
3165.	My Lady's Road, Belfast (south-west side to the side of No. 158 Ravenhill Road) – from a point 15 metres south-east of its junction with Ravenhill Road for a distance of 5.5 metres in a south-easterly direction.
3166.	St. Jude's Crescent, Belfast (east side) – from a point 34 metres north of its junction with Jameson Street for a distance of 5.5 metres in a northerly direction.
3167.	Main Street, Clogher (north-west side) – from a point 39 metres south-west of its junction with Station Road for a distance of 6.6 metres in a south-westerly direction.
3168.	Ballybeen Park, Dundonald (south-west side) – from a point 41 metres south-east of its junction with Ballybeen Square for a distance of 6 metres in a south-easterly direction.
3169.	Reihill Park, Irvinestown (south-west side of north-east parking area) – from a point 185 metres north-east and then north-west of its junction with Church Street for a distance of 3 metres in a north-westerly direction.
3170.	Kildrum Gardens, Londonderry (north-east side in a parking area) – from a point 115 metres south-east, then south-west, then south-east and then north-east of its junction with Rathlin Drive for a distance of 3 metres in a north-westerly direction.
3171.	Moyola Drive, Londonderry (north-east side in front of No. 82) – from a point 266 metres south-west and then south-east of its western junction with Drumleck Drive for a distance of 6.6 metres in a south-easterly direction."

The amendments provide for the introduction of parking places with unlimited waiting on the lengths of the roads specified in the Schedule and the removal of the items referred to in Article 2(2)(a).
