The Lurgan Road, Portadown (Stopping-Up) Order (Northern Ireland) 2024

Made - - - - 19th June 2024

Coming into operation 30th September 2024

The Department for Infrastructure(a) makes the following Order in exercise of its powers conferred by Article 68(1), (3) and (5) of the Roads (Northern Ireland) Order 1993(b) and now vested in it(c).

The Department in accordance with Article 68(4) of that Order proposes on the completion of works providing alternative facilities for road traffic to stop-up Lurgan Road, Portadown to motor vehicles at the lines described in the Schedule.

Notice has been published, served and displayed in compliance with paragraphs 1, 2 and 3 of Schedule 8 to that Order.

No objection has been received.

Citation, commencement and interpretation

- 1.—(1) This Order may be cited as the Lurgan Road, Portadown (Stopping-Up) Order (Northern Ireland) 2024 and shall come into operation on 30th September 2024.
- (2) In this Order "the developer" means Sustar Limited whose registered office is situated at 23 Annaghmore Road, Portadown, BT62 1NA.

Application

- 2.—(1) The developer shall carry out such works as the Department considers necessary for the provision of alternative facilities for road traffic and on the completion of works Lurgan Road, Portadown shall be stopped-up to motor vehicles at the lines described in the Schedule.
- (2) The Department shall carry out such works as it considers necessary to prevent or restrict to such extent as the Department thinks fit, access to the road described in the Schedule by motor vehicles.

- **3.**—(1) All existing cables, wires, mains, pipes or other apparatus placed along, across, over or under the road shall be retained.
- (2) All existing rights as to the use or maintenance of such cables, wires, mains, pipes or other apparatus shall be preserved.

LENGTHS OF ROAD TO BE STOPPED-UP

- 1. Lurgan Road, Portadown, at a line commencing at a point 19.5 metres south-west of its junction with Roundabout 6, Mandeville Road, Portadown more particularly delineated and marked A-B on map no. IN1/24/82628.
- 2. Lurgan Road, Portadown, at a line commencing at a point 20 metres north-east of its junction with Roundabout 7, Mandeville Road, Portadown more particularly delineated and marked C-D on map no. IN1/24/82628.
