**The Urban Clearways (Amendment) Order (Northern Ireland)
2024**

Made - - - - *4th December 2024*

Coming into operation *30th December 2024*

The Department for Infrastructure^(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997^(b) (“the 1997 Order”) and now vested in it^(c).

In accordance with paragraphs 1 and 2 of Schedule 1 to the 1997 Order, the Department has consulted such persons as it considers appropriate.

The Department has published a notice in compliance with Article 4(6) of, and paragraphs 1 and 3 to, that Schedule.

No objection or other representation has been received.

Citation and commencement

1. This Order may be cited as the Urban Clearways (Amendment) Order (Northern Ireland) 2024 and shall come into operation on 30th December 2024.

Amendments

2.—(1) Schedule 1 to The Urban Clearways Order (Northern Ireland) 2016^(d) is amended in accordance with paragraphs (2) and (3).

(2) Delete item no. 165 relating to Foyle Embankment, Derry/Londonderry.

(3) After item 199 add the following items—

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Urban Clearways Order (Northern Ireland) 2016 (“the Order”) by the deletion from Schedule 1 of the item specified in Article 3(2) and the addition to Schedule 1 of the items specified in Article 2(3).

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with The Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of this Order will in due course be placed on the road.
