# The Kinard Park, Garvagh (Abandonment) Order (Northern Ireland) 2025

Coming into operation					18th March 2025

The Department for Infrastructure(**a**) makes the following Order in exercise of the powers conferred by Article 68(1) and (5) of the Roads (Northern Ireland) Order 1993(**b**) ("the 1993 Order"), and now vested in it(**c**).

In accordance with Article 68(4) of the 1993 Order, the Department proposes to abandon the areas of road described in the Schedule on the completion of works providing alternative facilities for road traffic.

The Department has published, served and displayed a notice in compliance with paragraphs 1, 2 and 3 of Schedule 8 to the 1993 Order.

No objection has been received.

#### Citation, commencement and interpretation

**1.**—(1) This Order may be cited as the Kinard Park, Garvagh (Abandonment) Order (Northern Ireland) 2025 and shall come into operation on 18th March 2025.

(2) In this Order "the developer" means Dante Limited whose registered office is situated at 114 Grove Road, Swatragh, BT46 5QZ.

#### Application

**2.** The developer shall carry out such works as the Department considers necessary for the provision of alternative facilities for road traffic and upon completion, the areas of road described in the Schedule shall be abandoned.

**3.**—(1) All existing cables, wires, mains, pipes or other apparatus placed along, across, over or under the abandoned areas of road shall be retained.

(2) All existing rights as to the use or maintenance of such cables, wires, mains, pipes or other apparatus shall be preserved.
