ROAD TRAFFIC

The M8 Motorway (Junction 20, West Street, to Junction 24, Helen Street) (Temporary 50mph Speed Limit) Order 2010

Coming into force

5th October 2010
18th October 2010

The Scottish Ministers, make the following Order in exercise of the powers conferred by sections 2(1), 4(1) and 14(1) and (4) of the Road Traffic Regulation Act 1984(a), and of all other powers enabling them to do so.

In accordance with section 14(1)(b) of that Act they are satisfied that the traffic on the lengths of road specified in the Schedule should be restricted because of the likelihood of danger to the public which is not attributable to works that are being or are proposed to be executed on or near those lengths of road.

In accordance with section 14(3) of that Act they have had regard to the existence of alternative routes for the traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the M8 Motorway (Junction 20, West Street, to Junction 24, Helen Street) (Temporary 50mph Speed Limit) Order 2010, comes into force on 18th October 2010 and ceases to have effect on 19th October 2011.

Temporary speed restriction

2. No person shall use, or permit the use of, any vehicle on the lengths of road specified in the Schedule at a speed exceeding 50mph when such a restriction is identified as applying to a part or parts of those lengths of road by means of a traffic sign prescribed in Diagram 670 of the Traffic Signs Regulations 2002(b).

SCHEDULE

Article 2

1. That length of the main westbound carriageway of the M8/A8 Edinburgh - Greenock Trunk Road from a point 200 metres or thereby generally south of the intersection of the south kerbline of the A8 Paisley Road and the east kerbline of the M8/A8 Trunk Road to a point 145 metres or thereby west of the intersection of the west kerbline of re-aligned Helen Street and the south kerbline of the M8/A8 Trunk Road, a distance of 3.32 kilometres or thereby.
2. That length of the main eastbound carriageway of the M8/A8 Edinburgh - Greenock Trunk Road from a point 145 metres or thereby west of the intersection of the west kerbline of re-aligned Helen Street and the south kerbline of the M8/A8 Trunk Road to a point 185 metres or thereby generally south of the intersection of the south kerbline of the A8 Paisley Road and the west kerbline of the M8/A8 Trunk Road, a distance of 3.30 kilometres or thereby.
3. That length of connecting road from its junction with the main westbound carriageway of the M8/A8 Edinburgh - Greenock Trunk Road to a point 71 metres or thereby east of its junction with Dumbreck Road, a distance of 112 metres or thereby.
4. That length of connecting road from a point 45 metres or thereby east of its junction with Dumbreck Road to its junction with the main eastbound carriageway of the M8/A8 Edinburgh - Greenock Trunk Road, a distance of 167 metres or thereby.
5. That length of connecting road from its junction with the main westbound carriageway of the M8/A8 Edinburgh - Greenock Trunk Road to a point 85 metres or thereby east of its junction with Helen Street, a distance of 140 metres or thereby.
6. That length of connecting road from a point 40 metres or thereby east of its junction with Helen Street to its junction with the main eastbound carriageway of the M8/A8 Edinburgh - Greenock Trunk Road, a distance of 163 metres or thereby.
