ROAD TRAFFIC

**The M9/A90/M90 Trunk Road (Laurencekirk) (Temporary
Prohibition of Specified Turns) Order 2011**

Made - - - - *16th December 2011*

Coming into force - - *2nd January 2012*

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2) and 4(1) and 14(1)(a) and (4) of the Road Traffic Regulation Act 1984(a), and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that the traffic on the length of road specified in Part 1 of the Schedule should be prohibited from making any turn specified in Part 2 of the Schedule because works are being or are proposed to be executed on or near the said length of road.

In accordance with section 14(3) of that Act, they are satisfied that there is an alternative route suitable for traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the M9/A90/M90 Trunk Road (Laurencekirk) (Temporary Prohibition of Specified Turns) Order 2011, comes into force on 2nd January 2012 and ceases to have effect at midnight on 30th March 2012.

Prohibition of use of vehicles

2. No person shall use, or permit the use of, any vehicle on the length of road specified in Part 1 of the Schedule to this Order so as to make any turn specified in Part 2 of the Schedule when such prohibition is identified as applying to any part or parts of that length of road by means of traffic signs prescribed in Diagrams 612 and 613 of the Traffic Signs Regulations 2002(b).

Permission or direction of Police Constable

3. No provision of this Order shall apply to anything done with the permission or upon the direction of a police constable in uniform.

The functions of the Secretary of State were transferred to the Scottish Ministers by section 53 of the Scotland Act 1998 (c.46).

Exemption for emergency and works vehicles

4. No provision of this Order shall apply to a vehicle while being used in an emergency for fire brigade, coastguard, ambulance or police purposes or a vehicle being used for carrying out the works.

SCHEDULE

Article 2

In this Schedule “A90 Trunk Road” shall mean the M9/A90/M90 Edinburgh – Fraserburgh Trunk Road.

PART 1

That length of the A90 Trunk Road from a point 115 metres or thereby north of the junction with the A937 at the Laurencekirk northmost junction to a point 115 metres or thereby south of the junction with the B9210 to St Cyrus, a distance of 1.9 kilometres or thereby.

PART 2

1. All right turns from the southbound A90 Trunk Road to the A937 at the Laurencekirk northmost junction.
2. All right turns from the A937 at the Laurencekirk northmost junction to the southbound A90 Trunk Road.
3. All left turns from the northbound A90 Trunk Road to the A937 at the Laurencekirk northmost junction.
4. All left turns from the A937 at the Laurencekirk northmost junction to the northbound A90 Trunk Road.
5. All right turns from the northbound A90 Trunk Road to Keilburn Farm, Laurencekirk.
6. All right turns from Keilburn Farm, Laurencekirk to the northbound A90 Trunk Road.
7. All left turns from the southbound A90 Trunk Road to Keilburn Farm, Laurencekirk.
8. All left turns from Keilburn Farm, Laurencekirk to the southbound A90 Trunk Road.
9. All right turns from the northbound A90 Trunk Road to Burnside, Laurencekirk.
10. All right turns from Burnside, Laurencekirk to the northbound A90 Trunk Road.
11. All left turns from the southbound A90 Trunk Road to Burnside, Laurencekirk.
12. All left turns from Burnside, Laurencekirk to the southbound A90 Trunk Road.
13. All right turns from the southbound A90 Trunk Road to the B9210 to Laurencekirk.
14. All right turns from the B9210 from Laurencekirk to the southbound A90 Trunk Road.
15. All left turns from the northbound A90 Trunk Road to the B9210 to Laurencekirk.
16. All left turns from the B9210 from Laurencekirk to the northbound A90 Trunk Road.
17. All right turns from the northbound A90 Trunk Road to the B9210 to St Cyrus.
18. All right turns from the B9210 from St Cyrus to the northbound A90 Trunk Road.
19. All left turns from the southbound A90 Trunk Road to the B9210 to St Cyrus.
20. All left turns from the B9210 from St Cyrus to the southbound A90 Trunk Road.
