ROAD TRAFFIC

**The A92/A972 Trunk Road (B969 Western Avenue to the C49
leading to Star) (Temporary Prohibition of Specified Turns)
Order 2014**

Made - - - - *15th May 2014*

Coming into force - - *26th May 2014*

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 14(1)(a) and (4) of the Road Traffic Regulation Act 1984^(a) and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that traffic on the length of road specified in the Schedule should be restricted or prohibited because works are being or are proposed to be executed on or near that length of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the A92/A972 Trunk Road (B969 Western Avenue to the C49 leading to Star) (Temporary Prohibition of Specified Turns) Order 2014, comes into force on 26th May 2014 and ceases to have effect on 31st July 2014

Prohibition of specified turns

2. No person may use, or permit the use of, any vehicle on the length of road, or a part or parts of the length of road, specified in Part 1 of the Schedule to this Order so as to make any turn specified in Part 2 of the Schedule when a prohibition is identified as applying to that length of road, or a part or parts of that length of road, by means of the traffic signs prescribed in Diagrams 612 and 613 of the Traffic Signs Regulations 2002^(b).

The Scottish Ministers are the traffic authority by virtue of section 121A of the Road Traffic Regulation Act 1984 (inserted by the New Roads and Street Works Act 1991, Schedule 8, paragraph 70 and amended by S.I. 2001/1400) as read with section 151(1) of the Roads (Scotland) Act 1984 (c.54) (as amended by S.I. 1999/1750). The functions of the Secretary of State were transferred to the Scottish Ministers by section 53 of the Scotland Act 1998 (c.46).

Exemptions

3. No prohibition imposed by this Order applies to—

- (a) a vehicle while being used in an emergency for fire brigade, coastguard, ambulance or police purposes; or
- (b) a vehicle being used for carrying out the works.

SCHEDULE

Article 2

PART 1

SPECIFIED LENGTH OF ROAD

That length of the A92/A972 Kirkcaldy – Dundee Trunk Road from a point 130 metres or thereby north of its junction with the B969 Western Avenue, southwards to a point 50 metres or thereby south of the junction with the C49 leading to Star, a distance of 300 metres or thereby.

PART 2

SPECIFIED TURNS

1. All right turns from the southbound A92/A972 Kirkcaldy – Dundee Trunk Road to the B969 Western Avenue.

2. All right turns from the B969 Western Avenue to the southbound A92/A972 Kirkcaldy – Dundee Trunk Road.

3. All right turns from the northbound A92/A972 Kirkcaldy – Dundee Trunk Road to the C49 leading to Star.

4. All right turns from the C49 leading from Star to the northbound A92/A972 Kirkcaldy – Dundee Trunk Road.

5. All left turns from the southbound A92/A972 Kirkcaldy – Dundee Trunk Road to the C49 leading to Star.

6. All left turns from the C49 leading from Star to the southbound A92/A972 Kirkcaldy - Dundee Trunk Road.

7. All left turns from the northbound A92/A972 Kirkcaldy - Dundee Trunk Road to the B969 Western Avenue.

8. All left turns from the B969 Western Avenue to the northbound A92/A972 Kirkcaldy - Dundee Trunk Road.
