**ROAD TRAFFIC**

**The A90 Trunk Road (Northbound Slip Road from B980  
Castlandhill Road) (Temporary Speed Restrictions) Order 2015**

*Made* - - - - *10th July 2015*

*Coming into force* - - *29th July 2015*

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 14(1)(a) and (4) of the Road Traffic Regulation Act 1984<sup>(a)</sup> and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that traffic on the length of road specified in the Schedule should be restricted or prohibited because works are being or are proposed to be executed on or near that length of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

**Citation, commencement and cessation**

1. This Order may be cited as the A90 Trunk Road (Northbound Slip Road from B980 Castlandhill Road) (Temporary Speed Restrictions) Order 2015, comes into force on 29th July 2015 and ceases to have effect on 31st August 2016.

**Speed restriction**

2. No person may drive any vehicle on the length of road, or a part or parts of the length of road, specified in the Schedule to this Order at a speed exceeding 30mph miles per hour, 40 mile per hour or 50 miles per hour, as the case may be, when that particular restriction is identified as applying to the length of road, or a part or parts of the length of road, by means of the appropriate traffic sign prescribed in Diagram 670 of the Traffic Signs Regulations 2002<sup>(b)</sup>.

### **Exemptions**

**3.** No speed restriction imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011<sup>(a)</sup> when used in accordance with regulation 3(5) of those Regulations.

## SCHEDULE

Article 2

### SPECIFIED LENGTH OF ROAD

That length of road being the temporary northbound on slip road from the B980 Castlandhill Road at Ferrytoll to the M90/A90 Edinburgh - Fraserburgh Trunk Road, a distance of 630 metres or thereby.
