The A96 Trunk Road (Pitmachie) (50mph Speed Limit) Order 2017

 Coming into force
 3rd July 2017

The Scottish Ministers make the following Order in exercise of the powers conferred by section 84(1)(a) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section $84(2)(\mathbf{b})$ of the Road Traffic Regulation Act 1984 the Scottish Ministers have given public notice of their intention to make the following Order, and have complied with Parts II and III of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(\mathbf{c}).

Citation and commencement

1. This Order may be cited as the A96 Trunk Road (Pitmachie) (50mph Speed Limit) Order 2017 and comes into force on 3rd July 2017.

Speed restriction

2. No person may drive any motor vehicle at a speed exceeding 50 miles per hour on the length of road specified in the schedule of this Order.

Exemption

- 3. No speed restriction imposed by this Order applies to—
 - (a) vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations; or
 - (b) vehicles being used in an emergency for coastguard purposes.

Article 2

SPECIFIED LENGTH OF ROAD

The A96 Aberdeen – Inverness Trunk Road from a point 117 metres or thereby north west of its junction with the U61S Oyne Road in a northwesterly direction to a point 858 metres or thereby north west of its junction with the said U61S Oyne Road, a distance of 741 metres or thereby.
