ROAD TRAFFIC

The A83 Trunk Road (Inveraray) (Temporary Prohibition on Use of Road) Order 2018

Made - - - - *29th May 2018*

Coming into force - - *6th June 2018*

The Scottish Ministers make the following Order in exercise of the powers conferred by section 62(1) of the Roads (Scotland) Act 1984^(a) and all other powers enabling them to do so.

In accordance with section 62(1) of that Act, they are of the opinion that considerations of public safety or convenience require that traffic should be temporarily prohibited on the lengths of road specified in the schedule while filming on the road takes place.

Citation, commencement and cessation

1. This Order may be cited as the A83 Trunk Road (Inveraray) (Temporary Prohibition on Use of Road) Order 2018, comes into force on 6th June 2018 and ceases to have effect on 8th June 2018.

Prohibition on use of vehicles

2. No person may use, or permit the use of, any vehicle on the lengths of road, or a part or parts of the lengths of road, specified in the schedule of this Order when a prohibition is identified as applying to those lengths of road, or a part or parts of those lengths of road, by means of a traffic sign of the type described in item 8 (diagram 7105 – position of barrier to mark length of road closed or to guide traffic past an obstruction) of the sign table in Part 6 of schedule 13 of the Traffic Signs Regulations and General Directions 2016^(b).

Exemptions

3. No prohibition imposed by this Order applies to a vehicle being used—
- (a) in an emergency for fire brigade, ambulance, police or coastguard purposes;

- (b) in connection with the filming on the road; or
- (c) in connection with the placing of the required signage.

SCHEDULE

Article 2

SPECIFIED LENGTHS OF ROAD

1. That length of the A83 Tarbet – Lochgilphead – Campbeltown Trunk Road from its junction with the A815 Dunoon Road in a generally easterly and southeasterly direction to its junction with the B828 Lochgilphead Road, a distance of 7 kilometres or thereby.

2. That length of the A83 Tarbet – Lochgilphead – Campbeltown Trunk Road from a point 150 metres or thereby northeast of its junction with The Avenue, Inveraray in a generally northeast direction along Main Street South, Main Street West and Main Street East to its junction with Front Street East, Inveraray, a distance of 250 metres or thereby.
