**ROAD TRAFFIC**

**The A68 Trunk Road (Leaderfoot) (Temporary Prohibition on  
Use of Road) (No. 2) Order 2021**

*Made* - - - - *4th June 2021*

*Coming into force* - - *11th June 2021*

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 14(1)(b) and (4) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 14(1)(b) of that Act, they are satisfied that traffic on the length of road specified in the schedule should be restricted or prohibited because of the likelihood of danger to the public, or of serious damage to the road, which is not attributable to works.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

**Citation, commencement and cessation**

1. This Order may be cited as the A68 Trunk Road (Leaderfoot) (Temporary Prohibition on Use of Road) (No. 2) Order 2021, comes into force on 11 June 2021 and ceases to have effect on 13 June 2021.

**Prohibition on use of road**

2. No person may use, or permit the use of, any vehicle on the length of road, or a part or parts of the length of road, specified in the schedule of this Order when a prohibition is identified as applying to that length of road, or a part or parts of that length of road, by means of a traffic sign of the type described in item 8 (diagram 7105 – position of barrier to mark length of road closed or to guide traffic past an obstruction) of the sign table in Part 6 of schedule 13 of the Traffic Signs Regulations and General Directions 2016(b).

### **Exemption**

**3.** No prohibition imposed by this Order applies to a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes.

## SCHEDULE

Article 2

### SPECIFIED LENGTH OF ROAD

That length of the A68 Edinburgh – Carter Bar Trunk Road, from the B6360 Gattonside Junction, going in a generally southerly direction to the Ravenswood Roundabout, a distance of 1.3 kilometres or thereby.
