ROAD TRAFFIC

The A6091/A7 Trunk Road (Parkdaill) (40mph Speed Limit) Order 2022

Made - - - - 9th September 2022

Coming into force - - 16th September 2022

The Scottish Ministers make the following Order in exercise of the powers conferred by section 84(1)(a) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 84(2)(**b**) of that Act, they have given public notice of their intention to make the following Order, and have complied with Parts II and III of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(**c**).

Citation and commencement

1. This Order may be cited as the A6091/A7 Trunk Road (Parkdaill) (40mph Speed Limit) Order 2022 and comes into force on 16 September 2022.

Speed restriction

2. No person may drive any motor vehicle at a speed exceeding 40 miles per hour on the length of road specified in the schedule.

Exemption

- 3. No speed restriction imposed by this Order applies to—
 - (a) vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(**d**) when used in accordance with regulation 3(5) of those Regulations, or

Article 2

SPECIFIED LENGTH OF ROAD

That length of the A6091/A7 Melrose – Galashiels – Carlisle Trunk Road at Hawick from a point 230 metres or thereby south of its junction with Buccleuch Road in a generally south westerly direction to a point 430 metres or thereby north of its junction with the B711, a distance of 1.1 kilometres or thereby.
