**ROAD TRAFFIC**

**The A85 Trunk Road (Crieff) (Temporary 20mph Speed  
Restriction) Order 2025**

*Made* - - - - *11th February 2025*

*Coming into force* - - *21st February 2025*

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1), 4(1) and 14(1)(b) and (4) of the Road Traffic Regulation Act 1984<sup>(a)</sup> and all other powers enabling them to do so.

In accordance with section 14(1)(b) of that Act, they are satisfied that the traffic on the length of road specified in the schedule should be restricted because of the likelihood of danger to the public, or of serious damage to the road, which is not attributable to works.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

**Citation, commencement and cessation**

1. This Order may be cited as the A85 Trunk Road (Crieff) (Temporary 20mph Speed Restriction) Order 2025, comes into force on 21 February 2025 and ceases to have effect on 15 March 2025.

**Speed restriction**

2. No person may use or permit the use of, any vehicle on the lengths of road, or a part or parts of the lengths of road, specified in the schedule at a speed exceeding 20 miles per hour when a restriction is identified as applying to that length of road, or a part or parts of that length of road, by means of a traffic sign of the type described in item 1 (diagram 670 – maximum speed limit in mph) of the sign table in Part 2 of schedule 10 of the Traffic Signs Regulations and General Directions 2016<sup>(b)</sup>.

**Exemptions**

3. No speed restriction imposed by this Order applies to—

The functions of the Secretary of State were transferred to the Scottish Ministers by section 53 of the Scotland Act 1998 (c. 46).

- (a) vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011<sup>(a)</sup> when used in accordance with regulation 3(5) of those regulations, or
- (b) a vehicle being used in an emergency for coastguard purposes.

## SCHEDULE

Article 2

### SPECIFIED LENGTH OF ROAD

That length of the A85 Perth – Lochearnhead Trunk Road at Crieff from a point 10 metres or thereby north east of its junction with Murray Lane in a generally south westerly direction to a point 65 metres or thereby north west of its junction with Heathcote Road, a distance of 1177 metres or thereby.
