Relations (Consolidation) Act 1992 and they presented their claims within a reasonable period. The Tribunal therefore has jurisdiction to deal with their claims.

- 2. It is declared that the complaints of failure to consult in respect of proposed dismissals contrary to s 188 of the Trade Union and Labour Relations (Consolidation) Act 1992 brought by these twenty-one former employees of Hamon UK Ltd are wellfounded.
- 3. The Respondent is ordered to pay to the Claimants remuneration for a protected period of 90 days from 18 September 2023.
