**Order**

**At a hearing** held at Port Talbot Justice Centre on the 29 April 2016, the Tribunal made an order pursuant to Rule 14 (1)(a) of the Tribunal Procedure Rules 2008 (as amended) prohibiting the disclosure or publication of any matter likely to lead members of the public to identify any child, family or witness identified in the current proceedings. Such order shall stand until further order by the Tribunal.

**UPON** the Appellant consenting to enter into a period of voluntary suspension of the registration of bright Sparks Taibach Nursery pursuant to Regulation 46 of the Child Minding and Day Care (Wales) Regulations 2010 starting at 5pm on the Friday 29 April 2016 and continuing either until the conclusion of the South Wales Police investigation (if no further action is taken by them against the Appellant) or if a report is made and submitted for their consideration, a decision by the Crown Prosecution Service about criminal proceedings

**AND UPON** CSSIW and/or the Respondent's representative explaining to the Appellant their right to impose a further period of suspension under Regulation 45 if the circumstances so required and the Appellant right to extend the voluntary extension similarly

**AND UPON** the above being a formal recording of the terms of agreement between the parties, a signed copy of which is attached to the order marked Annexe A

**IT IS ORDERED that**

1. The Respondent withdraws their opposition to the appeal with immediate effect.
2. The suspension imposed on the 23 March 2016 is lifted from 5pm on the 29 April 2016.
3. No order is made as to costs.
