

## Freedom of Information Act 2000 (FOIA)

### Decision notice

### Decision

---

1. The complainant wrote to Wirral Borough Council (the "council") and requested the following information:
  - Information relating to monitoring of the Care Quality Commission implementation plan.
2. The Information Commissioner's (the "Commissioner") decision is that the council did not deal with the request for information in accordance with the FOIA in the following way:
  - It failed to provide a response to the request within the statutory time frame of 20 working days.
3. The Commissioner requires the council to take the following steps to ensure compliance with the FOIA:
  - To confirm or deny whether the requested information is held.
  - If information is held, either provide it or issue a valid refusal notice as set out in the FOIA.
4. The public authority must take these steps within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the high court (or the court of session in Scotland) pursuant to section 54 of the Act and may be dealt with as a contempt of court.

## Request and response

---

5. On 14 March 2011, the complainant wrote to the council and requested information in the following terms:

"(...the North West Joint Improvement Partnership will provide a monitoring function to determine how well the Council has responded to the findings of the Care Quality Commission Inspection Report of May 2010. At the time of writing, the Joint Improvement Partnership has not advised how it will conduct its assessment).

Please could you disclose:

1. Will the NWJIP be providing a monitoring function
2. How will NWJIP provide a monitoring function?
3. How will the assessment of progress be made?
4. How will the assessment be communicated?
5. If no arrangements are in place, at what point will WBC actually make arrangements around monitoring from NWJIP?

Could you also provide all emails and correspondence between WBC and NWJIP since September 2010."

6. On 26 April 2011 and 3 October 2011 the complainant wrote to the council seeking a response to their request.

## Scope of the case

---

7. In July 2011 the complainant contacted the Commissioner to complain about the council's failure to respond to their request.
8. The Commissioner has investigated whether the council has responded to the request within the statutory time limit set within the FOIA.

## Reasons for decision

---

9. Section 10(1) of the FOIA states that on receipt of a request for information a public authority should respond to the applicant within 20 working days.
10. The Commissioner contacted the council on 7 September 2011 and 5 October 2011 and advised that he had received a complaint about its failure to respond to the request. The council neither responded to the request nor did it acknowledge receipt of the Commissioner's

11. It is clear to the Commissioner that, in this case, the council has failed to respond to the request in the time limit set within the FOIA.

### **Other matters**

---

12. Although they do not form part of this decision notice, the Commissioner wishes to note his concerns about the severe delays involved in this case.
13. The council's ongoing failure to respond to the request, despite being repeatedly prompted to do so by the complainant and the Commissioner raises concerns that the council might not take its responsibilities under the FOIA seriously.
14. The Commissioner has logged the delays involved in the handling of this request and expects that, in future, the council will respond to requests within the time limits required by the FOIA.

## Right of appeal

---

15. Either party has the right to appeal against this Decision Notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
