Decision (including any steps ordered)

1. The complainant has requested information from the Northern Ireland Ambulance Service (NIAS) regarding a recruitment process. The NIAS has not to date provided a response to the complainant's request.
2. The Commissioner's decision is that the NIAS has breached sections 1(1)(b) and 10(1) of FOIA.
3. The Commissioner requires the NIAS to take the following steps to ensure compliance with the legislation.
 - To provide a full response to the complainant's request
4. The NIAS must take these steps within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Act and may be dealt with as a contempt of court.

Request and response

5. On 4 January 2019, the complainant wrote to the NIAS and requested information in relation to a recruitment process as mentioned in paragraph 1 of this Notice.

6. On 6 February 2019, still not having received a response, the complainant contacted the Commissioner, who wrote to the NIAS on 12 February 2019 requesting that it respond to the complainant by 26 February 2019.

Scope of the case

7. The complainant contacted the Commissioner on 14 March 2019 to complain that he had still not received a response to his request and it was by now well beyond the 20 working day statutory time limit. The Commissioner spoke to the NIAS at the time and the NIAS stated that it would issue a response shortly. So far no response has been forthcoming.
8. The Commissioner has considered the NIAS' handling of the complainant's request.

Reasons for decision

Section 10(1): Time for compliance

9. Section 1(1)(a) of FOIA requires a public authority to inform the complainant in writing whether or not recorded information is held that is relevant to the request. Section 1(1)(b) requires that if the requested information is held by the public authority it must be disclosed to the complainant unless a valid refusal notice has been issued.
10. Section 10(1) requires that the public authority comply with section 1 promptly and in any event no later than 20 working days after the date of receipt of the request.
11. The Commissioner notes that the complainant's request for information was made on 4 January 2019, however he did not receive, and has not to date received, any information in response to this or a valid refusal notice. From the information provided to the Commissioner in this case it is evident that the NIAS did not respond to the complainant under the FOIA within the statutory time frame and therefore it has breached section 10(1) of the FOIA.
12. The NIAS has not confirmed that it holds information within the scope of the complainant's request and has not to date provided any information in relation to that request. Therefore it has breached section 1(1)(b) of FOIA.

Right of appeal

13. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
