Freedom of Information Act 2000 (FOIA) Decision notice

Decision (including any steps ordered)

- 1. The complainant has requested information about a programme on BBC Scotland. The above public authority ("the public authority") stated that the information was held for a derogated purpose and was therefore not covered by FOIA.
- 2. The Commissioner's decision is that the requested information would be held for a derogated purpose and therefore the public authority was not obliged to provide it.
- 3. The Commissioner does not require any steps to be taken.

Request and response

- 4. On 16 May 2024, the complainant wrote to the public authority and requested information in the following terms:
 - "1) From January 1st 2024 to present, daily information on the Reporting Scotland evening news show on BBC Scotland, including:
 - a. Live broadcast viewing figures
 - b. Views on BBC iPlayer in 24 hours since broadcast

- c. Names of any elected politicians who appeared on the show
- d. The leading news story covered
- 2) For 2023, daily information on the Reporting Scotland evening news show on BBC Scotland, including:
 - a. Live broadcast viewing figures
 - b. Views on BBC iPlayer in 24 hours since broadcast
 - c. Names of any elected politicians who appeared on the show
 - d. The leading news story covered"
- 5. The public authority responded on 22 May 2024. It stated that the information was covered by the derogation and therefore it was not obliged to provide it.

Reasons for decision

- 6. The following analysis considers whether the requested information was derogated.
- 7. There is a considerable history of case law involving the derogation which can be found on the <u>Decision Notice support materials page</u> (see "FOIA Schedule one, Part VI"). In short, information is not covered by FOIA if it relates to this public authority's output whether that be via TV, radio or the internet. This is known as derogation.
- 8. The requested information clearly relates to output. Parts C and D relate to the selection of materials for broadcast. Parts A and B relate to the process for evaluating previous broadcasts.
- 9. This information may also be held for other purposes and Parts 3 and 4 will have originally been in the public domain. This is irrelevant to the question of whether it should now be disclosed. If the information is held, even in part, for a derogated purpose, it is not covered by FOIA and therefore the public authority is not obliged to consider it for disclosure.
