***SUPPLEMENTARY DECISION***

1) On 6 May 2010 I issued decision O-138-10 which, in the application for rectification, found in favour of Mr Robert Busbridge. As a private litigant I required him to provide a brief schedule of costs setting out any disbursements incurred, any other financial losses claimed and a statement of the time spent in dealing with the proceedings.

2) Mr Robert Busbridge has provided a schedule which shows that he spent 45 hours on the proceedings and incurred disbursements of £56.50. In accordance with the comments of Richard Arnold QC, acting as the Appointed Person in South Beck B/L O/160/08 I award the applicant the following:

Hours 45 x £9.25 per hour = £416.25  
Disbursements = £56.50

3) I order the applicant, Mr Martin Busbridge to pay Robert Busbridge the sum of £472.75. This sum to be paid within seven days of the expiry of the appeal period or within seven days of the final determination of this case if any appeal against this decision is unsuccessful.

4) Also within decision O-138-10 issued on 6 May 2010, with regard to the application for a declaration of invalidity, I found in favour of the applicant Mr Robert Busbridge. As a private litigant I required him to provide a brief schedule of costs setting out any disbursements incurred, any other financial losses claimed and a statement of the time spent in dealing with the proceedings.

5) Mr Robert Busbridge has provided a schedule which shows that he spent 65 hours on the proceedings and incurred disbursements of £68.50. In accordance with the comments of Richard Arnold QC, acting as the Appointed Person in South Beck B/L O/160/08 I award the applicant the following:

Hours 68 x £9.25 per hour = £601.25

Disbursements = £68.50

6) I order the registered proprietor, Mr Cook to pay Robert Busbridge the sum of £667.75. This sum to be paid within seven days of the expiry of the appeal period or within seven days of the final determination of this case if any appeal against this decision is unsuccessful.
