Mr. G.S. Suraweera for the Crown Mr. Adv. Sunil Rodrigo inst. by Mr. D. Balasuriya for the 1st accused. Mr. D. Balasuriya for the 2nd, 3rd, 4th, 5th, 6th and 7th accused.

Mr. G.S. Suraweera submits the authority from the Acting Solicitor General to prosecute 10 in this case. These papers are filed of record.

Mr. G.S. Suraweera for the Crown states that before the indictment is read, he has to add one more production to the List of Productions. He moves to add Morris Minor Car bearing Registered No. EL 5241 as P13. He states that this production has been referred to in the charge-sheet and it has been produced in the Lower Court but not marked. It has also been referred to in the evidence given in the Lower Court and the complainant, witness No. 1 was asked to bring same today.

Mr. Sunil Rodrigo for the 1st accused states that the production which Mr. Suraweera moves to mark as P13 is not on the back of the indictment and as such objects to this production being marked at this stage.

H.A. Hendrick Appuhary, affd., 39 yrs., Sinhalese, Buddhist, Businessman, residing at Wellawatta.

I am the 1st accused in this I remember witness Punchi Banda 10 who gave evidence in this case. knew him for the last 4 or 5 years. I have done business with him. Punchi Banda knows 4th accused Siripala Perera. Punchi Banda had taken cars from Siripala Perera. I remember September 1960. Punchi banda bought a car from me for Rs. 4000/-The number of that car is EY 1840. I remember 16.10.60. On 16.10.60 I bought car No. EL 5241 from Wilbert 20 Appuhany. That receipt I obtained from Wilbert Appuhany. Wilbert Appuhany colivered the car to me. I owed Punchi Banda a sun of Rs.500/-. Punchi Banda came a number of times to ask for that money. At that time I did not have money. I said that I had no money and after that he insisted on my..... and I had asked him to take the car. 30 Apart from the receipt of the car. Wilbert Appuhany gave ne the registration card also. After Punchi Banda came and met me a number of times, I had no money to give him. I gave him the car No. EL 5241 to keep it with him. Punchi Banda when he came to meet me, regarding the earlier car, told me that he net with an accident. He said that he had written to the Finance Company 40 to get the damages. I remember the day as December 1960. Punchi Banda told me that Austin car was seized by the Finance Company. No, he did not say that the car was taken but I got information.

I did not meet not meet Punchi Banda. 10 Punchi Banda between February and this incident. I brought back the car from Punchi Banda. I sent a nessage and he said that he would come and give the car. But he never came. I made an entry at the Negonbo Police Station on the day of the incident. We went to meet Punchi Banda. On our way we met him going away. I did not write 4D6. Wilbert Appuhany gave ne the post card. I produce 4D2 and 4D6. On any day 30 I did not have any intention of selling this car to Punchi Banda. That car is mine. That Morris minor car belonged to me. 4th accused is a relation of mine. lives at Horagasmulla, at Diulapitiya, near the hospital. I have sent Siripala in search of this car. Siripala had written letters to Punchi Banda on my behalf.

Cross-Examination Cross-examined by Mr. Balasuriya.

At the time I bought the Morris
Minor car, Punchi Banda came to my car
sale to demand for the money. As he was
troubling me I gave the transfer book to
Punchi Banda. I had no intention of
selling this car to Punchi Banda, when
I gave him the transfer books. When
Punchi Banda came I had no money with me
to pay him. Punchi Banda stole my car

while it was being used by one Silva. Silva complained to me that Punchi Banda had stolen the car. I made a complaint against Punchi Banda at the Negombo Police Station. In this case I have summoned the Negonbo Police to give that evidence. An Inspector of Police, Negombo gave ne a letter to be given to the Kegalla Police. gave that letter to Inspector Ratnayake of the Kegalla Police. Police did not take any action regarding I was not satisfied my complaint. with the treatment neted out to me by the Kegalla Police regarding this case. I sold the A40 car to Punchi Banda.

I buy cars and sell cars. That is the business I do. My home is at Wellawatta. 30 I have my car sale in Negombo. We all are not from Negombo. 3rd accused is not from Negonbo. Others are from Negombo. know then very well. They do not help me in my car sale. Siripala helps me in my business. 3rd accused is residing at Wellawatta. He lives about ½ a mile away from my house. 3rd accused is my brother. The Rs. 500/- I owed Punchi Banda I had not paid. I know that the certificate of 40 registration has no value at all. That certificate was not registered in my name. I had given similar certificates to other people and taken noney. Punchi Banda agreed to keep the book till his Rs.500/- was paid. I handed over the transfer forms to Punchi

Banda. The transfer forms regarding car No. EL.5241 were not signed by me. transfer forms given to me by Wilbert Appuhary when I bought the car from him, I handed over to Punchi Banda. If he suspected ne, I asked him to keep those forms with hin. I did not register the car in my name. When I buy a car I get a receipt and when a purchaser comes I 10 register the car in his name. I obtained the receipts in my name, because I pay They were blank forms signed for it. by Wilbert Appuhany. I did not get the registration in my name. If I did not sell the car, then I would register the car in my name. I do not know anything about the robbery that took place in Negombo except what Silva told me. Silva has not come today. I did not see 20 Silva today. I have instructed my Proctor to surmon Silva and Piyaratne. I know Silva of Negombo. I cannot remember as to how many times I had seen Silva in Court. I had seen him 3 or 4 times in Court. I did not see Silva today. Silva is not giving evidence for me. Piyaratne had come to court 3 or 4 times. I have spoken to Piyaratne. It is not correct that the car was not stolen on 30 31.12.61. If I had stated so to the Police, it is not correct. There was no dispute with Punchi Banda regarding some money. Punchi Banda was a friend of mine. I met him on the day in question. him to return my car. He asked me to take the car away and he said that he would come on the next day to finalise the transaction. He did not create any trouble. He gave me the car. I took it away. 40 know that he had done a wrong. We acted in a friendly way. Negonbo Police had asked me to inform them if the car was found. did not go to the Negonbo Police Station. I went to the Diulapitiya Police Station. When I made the complaint I did not expect any trouble. I admit having told the Diulapitiya Police that I came to make that complaint in order to prevent further troubles. I know that Punchi Banda was 50 angry with me. Siripala Perera cane with

me on that day. Dharmasena also came. Lany also came. Henry Fernando did not come on that day. I did not tell the Police Henry Fernando came with me that 7th accused did not come on that day. In all 4 persons came with me. We came in two vehicles. One car is Ford No. EL 8229. 5th accused drove that car. The number of the other car is 1 Sri 4350 and it was driven by me. Two persons 1.0 travelled in that car, and two persons travelled in the other car. Dharmasena came from Nuwara Eliya and we met him at Kegalla. I told him that I had come to take my car and he also joined up. I do not know that Punchi Banda had registered the car in his name. I do not know whether the car was in the name of any one else. We came to the Police Station. I deny that I was arrested by 20 P.S. Samarakoon at the Salgado Bakery. Sergeant Samarakoon says that, it is not correct. It is not correct that I was in the Salgado Bakery. Sergeant Sanarakoon went there. I came to the Police Station on my own, and I made a statement to the Police station on my own, and I made a statement to the Police. I signalled Punchi Banda to stop the car. I deny that I told 30 the Police that as Punchi Banda did not stop the car, I overtook his car and stopped the car. I asked Punchi Banda as to why he did not return the car. Thinking that the Police would harass me, I went to the Police Station. I knew that Punchi Banda was not angry with me. The Police had assaulted my watcher who watched my house. He had been assaulted by the Police. had not made a complaint regarding that 20 assault. The Police had no reason to assault hin. 2nd accused had seen Punchi Banda. I do not know why the 2nd accused was implicated in this case. I did not go in search of Punchi Banda, when he did not come back. I have asked for the Certificate of registration. After I made the complaint at the Divelepitiva Police Station, the car was in the house of the owner of the sales. The name of 30 that person is Karunaratne. I kept the car at the house of Karunaratne. Police found the car in the house of Karunaratne. I was not there when the Police recovered the car. I did not go to show the car to the Police. hear that there was a case and we cane and surrendered. The Police told me that we had stolen a car. Although I knew that I was implicated in the 40 robbery of a car, I came to the Police Station about 14 days later. that an innocent nan had been assaulted in a robbery case. I did not come to see him. I did not come to retain a lawyer. I gave my address as Horagasmulla. That is the place where 2nd accused is residing. It is about 14 miles away from the place of Karunaratne. It is not

correct to say that the car was found in my garden. The car was not used by anyone when it was in the house of the owner. It is not correct that engine of the car was warm when the Police found it. The Police found it about 14 miles away from my house. P.S. Samarakoon who gave evidence is not angry with me. When he went, the doors of my house were closed. I cannot remember when I came and surrendered at the Police Station. cannot remember when the Police found The car No. EL 1840 was not the car. registered in my name. One Albert Fernando was the owner of that car. I had bought that car also on a receipt. It was not transferred in my name.

I went in the car to Colombo till it was recovered by the When the Police recovered the car I was not present. 2nd accused is my watcher. About 8 hours after I left the car, the Police had removed the car. During that 8 hours no one used the Therefore, the engine could not have been warm at the time the Police recovered the car. I cannot remember what I stated on the last date. the 7th accused. He is called "Kangetaralahany". He did not come with me to take the car from Punchi Banda on that day. I made a statement to the Police. I did not say to the Police that on that day Siripala Perera, Dharnasena Lany, Henry Fernando and Kangetaralahany came in a Ford Prefect car, and in a Morris Wagon to Hiriwadunna to meet Punchi Banda. Siripala Perera is the 4th accused. Dharmasena is the 3rd accused. Lany is the 5th accused. Henry Fernando is the 6th accused. Kangetaralahamy is the 7th accused. an not producing the complaint I made to the Negombo Police alleging that Punchi Banda had stolen the car. not summoned the Negombo Police to produce that complaint. The other car met with an accident somewhere November. I cannot remember the date. According to me I came to Kegalla in search of Punchi Banda. Before that I

had gone and asked Punchi Banda to give back the car to me. When I came to take the car from Punchi Banda, Punchi Banda told me that the car was in a garage. He promised to give the car to me. Punchi Banda promised to give the car, and as he 20 did not come I sent a telegram to the C.M.T. Before I came to Kegalla I have sent that telegram. I have not sent that telegram to the C.M.T. I sent a registered letter to the C.M.T. told Silva to send a telegran to the C.M.T. asking him not to register the car in the name of Punchi Banda. It was after my first trip to Kegalla. I also sent a registered letter to the 30 C.M.T. because I thought that Punchi Banda would get the car registered in his name. I cannot remember the date. The telegram was sent by Silva. letter was sent by Wilbert Appuhany. Punchi Banda did not come I did so. Thereafter I sent him a telegran but he did not come. One Carolis Silva was the owner of that Ford 30 Prefect car which also came on that day. That Ford Prefect car is kept at Horagasmulla. The two cars did not start together from Diulapitiya. I with Siripala, Dharmasena and Lany came in the Ford Prefect car. The number of that Ford Prefect Car is EL 8629. was driving that car. I was going to 40 take that car from Punchi Banda. We met the Morris wagon at Kegalla. Dharmasena was the owner of the Morris Wagon at that time. He had told us that he would be coming to Kegalla from Kandy to sell that Morris Wagon. I met him near Nilwakka hotel, Kegalla, Diulapitiya is about 35 miles away from Kegalla. He came to sell that Morris Wagon to

I had seen the Wagon before this. me. 3rd accused came from Kandy on that day. I looked at the wagon. took place in the heart of the town, I tested the car on our way. who drove the car. I was going to Hiriwadunna. I told the Police that 4 of us came in 2 vehicles to meet Punchi Banda at Hiriwadunna. That 70 road was a short out to us. cannot say what the distance from Rambukkana to Diulapitiya is. I cannot remember having travelled along that road earlier. Others told me that this road was shorter. Therefore I wanted to go along that road. The transaction took place about 2 or 3 miles away from the house of Punchi Banda. We went along Kegalla Ramukkana Road. I knew that 20 the Insurance Certificate and the registration certificate were with Punchi Banda. I could not do any transaction without these two certificates. Funchi Banda and I were acting as best friends. Punchi Banda said that he would come on the next morning. I deny that I came and removed the car forcibly. I say that it was a friendly 50 transaction. I cannot say why Punchi Banda implicated me in this false case.

M.T. Siripala Perera, Affd., 22 yrs., Sinhalese, Buddhist Businessman, residing at Horagasmulla.

I am the 4th accused in this case. 10 I am a relation of the 1st accused. We do business together I know the complainant Punchi Banda in this case. Punchi Banda had car transactions with me for the last 4 years. Punchi Banda is a friend of mine. As 1st accused is with me, Punchi Banda came to know the 1st accused through me. On 29.12.61 I sent a telegram to Punchi Banda. Shown Pl. I sent this telegram to Punchi Banda. 20 Punchi Banda lives at Hiriwadunna. I sent the telegram to him asking him to bring the transfer papers of the Morris Minor car. I cannot remember the date on which I sent him the telegram. It was a Morris Minor car. I received a reply to the telegram. I received a post card. Shown I identify the signature of Punchi 4Dl. Banda on 4D1. He had sent the post card from Hiriwadunna. I am sure that post 30 card was sent by Punchi Banda. In that post card he says "Please bring papers regarding my car as he was sick" cannot remember in which month I received the post card. 1st accused had given a Devon Car to Punchi Banda, and Punchi Banda has asked in that post card to bring the papers regarding that car. 1st accused, another person and I took those papers to Punchi Banda. I remember 6.2.61. 40 That is the day on which I went to bring the Morris minor from Punchi Banda. I went with 1st accused on that day. Punchi Banda had brought that car by force. The owner of the Morris minor was the 1st accused.

We did not bring that car forcibly.

Cross-examined by Mr. Balasuriya. Punchi Banda came to know the 1st accused through me.

- Q. Did Punchi Banda write several letters to you prior to your receipt of this postcard?
- A. Yes.

Whenever we sell a car, Punchi Banda had signed as a witness.

Q. Did you identify the signature of Punchi Banda?

A. Yes.

The postcard was sent in reply to my telegram. I know that the postcard is from Punchi Banda because I had sent him the telegram on the previous day.

- Q. Was that telegram sent by you in December 1960?
 - A. Yes.
 - Q. Do you remember the time the 1st accused lost his car? Was that in December 1960?
 - A. I cannot remember the date. I was aware that the 1st accused lost the Morris Minor car.
- Q. You sent the telegram to Punchi Banda to get back the documents, as Punchi Banda and 1st accused both are your friends?
 - A. Yes.

Because of me Punchi Banda had transactions with the 1st accused. It was I who introduced Punchi Banda to the 1st accused. There was no reason to examine the signature of Punchi Banda. Punchi Banda had sent letters to me earlier and his signature is similar Punchi Banda signs like this. to this. Any other person can send a post card like 4D1. I cannot remember whether Punchi Banda denied having sent that postcard to me. We did not send the postcard to E.Q.D. The postcard was received after the telegram was sent. I cannot remember the date when I received the postcard. I cannot remember the date on which the telegram was sent. I do business in cars. I have nothing to do with Government hospitals. I live close to Government hospitals. the hospital. The Police had gone in search of me. I was not at home when the Police came in search of me. The Police came in search of me on the day the car was lost. I came to know that the Police were in search of me about 4 days later. I was present in Court when the 1st accused gave evidence in Court. 17.2.61 at 9.30 a.m. we came to the Police Station. Earlier I did not know Sergeant Samarakoon. He is not angry with me. On that day I did not go to Salgado Bakery to have tea. I was not in the Salgado Bakery at about 9 a.m. on that

If my name appears in the Police books, I do not know how it had come there. I told the Police that Hendrick Appuhamy alias 20 Sekera is a relation of mine. stated that Punchi Banda of Hiriwadunna is known to me. I told the Police that I came on this trip at the instigation of the 1st accused. I came in car No. EL 8229. It was driven by Lany. is the 5th accused. In the car Dharmasena did not come. Kangetaralahamy also did not come in that car. 1st accused came in the car. No one else 30 came in the car. I did not tell the Police that Dharmasena and Kangetaralahamy came in the car. Dharmasena did not get into that car at any stage. after the two cars went towards Hiriwadunna. One is a wagon No.4350. When we were going, we saw Punchi Banda's car going ahead. That car was EL 5241. We tried to overtake that car, but 40 Punchi Banda went and stopped the car at Hiriwadunna, junction. 1st accused and Dharmasena went up to the car and requested Punchi Banda to give the car. 4. At the same time and place aforesaid the above named accused did commit robbery of the said motor car belonging to K.M. Punchibanda an offence punishable under Section 380 read with Section 32 of the Penal Code.

According to K.M. Punchi Banda on the day in question he was driving his car Morris Minor No. EL 5241 from Kegalla to Rambukkana at about 9 a.m. in the norming. On the way he gave a lift to Messrs. M.R. Gunaratne and Wickramapala. As they were approaching Hiriwadunna a Ford Prefect car 30 overtook them and tried to stop his car. He recognised the 1st accused driving the Ford Prefect Car. Almost at the same time there was a Morris Wagon following his car. At a certain stage the Ford Prefect blocked his passage and he stopped his car. Then about 10 to 12 persons got out from the Ford Prefect car and the Morris Wagon and came towards him. Among them he recognised the 1st, 3rd and 4th accused. The 3rd 40 accused pulled him out of the car. The two passengers who accompanied him got out of the car. He recognised the 1st accused having a revolver in his hand. The others had iron rods and clubs. Then the 3rd accused got into the driving seat and turned the car and went off. The other two

vehicles followed his Morris Minor car. He immediately went to the Kegalla Police and made a complaint. During the course of the inquiry he pointed out the 2nd accused to the Inspector R.W. Amarasinghe as one of these who took part in the robbery of his car. At an identification parade held in the Magistrate's Court he identified the 6th, and the 7th accused as two of the persons who came with the 1st accused on the day in question.

Punchi Banda stated that he had known the 1st accused for some time. He was a car broker. In 1959 he the witness was in possession of a Ford car. In 1960 the 1st accused promised to sell his car and get him another car. meanwhile he had asked him to use an A40 car. Some time later the 1st accused said that he could give him a Morris Minor Car No. EL 5241 in exchange for his Ford Prefect car. The 1st accused also said that in addition he could have cash Rs. 500/-. This transaction was entered upon on 16.10.60 but he did not take the Morris Minor car as he had to return the Austin Car to the 1st accused. The 1st accused came to his house a few days later and stated that the payment of Rs.500/- in addition to the exchange was too much for a Ford Prefect car and he wanted him to return the money. Before this the 1st accused had sent him the Morris Minor car along with the transfer forms and the registration certificate. He refused to give back the Rs.500/-. The 1st accused thereupon uttered a threat that he would remove this car before long.

However he perfected the transfer forms and sent them to the Registrar of Motor Vehicles. He produced the certificate of registration which was marked P3. According to P3 the Morris Minor car No. EL 5241 was transferred to Punchi Banda on 20.12.60.

The witness stated that on the day in question he was in possession of car No. EL 5241 and those accused robbed him of this car. Witness Gunaratne stated that he was travelling with Punchi Banda on the day in question. Two cars blocked the car driven by Punchi Banda and a number of persons got out of the car armed with deadly weapons. 10 them one person had a revolver. At the identification parade he identified the 3rd and the 4th accused as two of the persons who stopped the car driven by Punchi Banda. Witness Wickramapala also described how the two vehicles stopped the car driven by Punchi Banda. He said that a number of persons rushed up and some of them pulled out Punchi Banda from the car and took 20 away the car. On the evidence placed by the prosecution I am satisfied that car No. EL 5241 was in the possession of Punchi Banda and this car was removed by force on the day in question.

The 1st accused 4th accused and the 7th accused gave evidence for the defence. According to the 1st accused car No. EL 5241 belonged to him. He had not sold it to Punchi Banda. In support of his contention he referred to receipt P4 given to him by Wilbert Appuhamy on 16.10.60. this document was in the possession of Punchi Banda. According to Punchi Banda the 1st accused gave him this document along with the transfer forms. According to document 4D6 Hendrick Appuhamy the 1st accused had sent a Postcard to Don Wilbert Appuhamy asking him to inform the Office of the Commissioner of Motor Transport to effect the transfer of Morris Minor car No. EL.5241 belonging to him in favour of K.M. Punchi Banda. Wilbert Appuhamy in his evidence stated that he sold car No. EL 5241 to the 1st accused. At the same time he said that the sale was on behalf of Punchi Banda.

I reject the evidence of the 1st accused that he was the owner of car No. EL.5241. According to the 1st accused Punchi Banda had removed this car from one Silva of Negombo. However there is ample evidence placed by the prosecution that Punchi Banda was forced to part with this car. I am unable to accept his evidence in the light of what took place according to prosecution witnesses Wickramapala and Gunaratne on the day in question.

10 If the intention of the 1st accused merely to take back car No. EL. 5241 peacefully from Punchi Banda one would have not expected him to visit this place with a number of persons in two vehicles. Besides the Police found it difficult to trace this car. According to P.S. Samarakoon car No. EL. 5241 was found in the house of the 1st accused parked in the garden, at about 20 There was no one in the house. The engine of the car was warm and it appeared that someone had just left the car there. I also accept sergeant Samarakoon's evidence that he found the 1st, 3rd and 4th accused at Salgado Bakery having tea. According to the 1st accused the three of them were on their way to the Police Station when they were arrested. The 1st and 7th accused gave evidence but have not explained as to 30 why they were found missing from their respective homes at the relevant period. I disbelieve the 1st accused as regards his being arrested by the Police on the way to the Police Station along with the 3rd and 4th accused.

As regards the 1st charge the crown has proved that these accused along with others had set out on this day with the object of committing robbery of Car 40 No. EL. 5241. I find all the accused guilty.

As regards the 2nd charge witness Punchi Banda stated that the 1st accused had a revolver. Witness Gunaratne stated that one of those who stopped the car of Punchi Banda had a revolver I accept the evidence of Punchi Banda about 1st accused having a revolver and I find him guilty on count No. 2.

As regards the charges 3 and 4 I am satisfied that the witness Punchi Banda was in possession of car No. EL 5241. The prosecution has led evidence that this car was 10 removed by the 1st accused and his The 1st accused himself had made a statement at the Divulapitiya Police Station after removing this car of the fact that he had removed the car. I hold that this car was removed by force by the 1st accused and the other accused in the 20 indictment. I find all the accused guilty on count 3 and also guilty on count 4.

- 3. The accused were on the 5th of January 1963 convicted and this accused was sentenced to 3 months imprisonment on count one and 3 months R.I. on Count 3 and 3 months R.I. on Count 4 and to serve in all 7 months R.I.
- 4. Being aggrieved with the said conviction and sentence this accused appeals to Your Lordships' Court on the following among other grounds that will be urged by counsel at the hearing of this appeal.
- 5. It is respectfully submitted that (a) the prosecution in this case has failed to substantiate the charges and has failed to prove in law the 40 respective charges against the respective accused.

- (b) The learned District Judge has failed to consider either adequately or properly or at all the defence of the respective accused individually and separately
- (c) the learned District Judge has failed to address his mind adequately and properly to the evidence placed by the respective accused in support of their respective cases

- (d) the learned District Judge has failed to give reasons for his judgment.
- 6. The prosecution led in evidence a statement made by the 1st accused to the Divulapitiya Police Station marked P6 which is a confession and in any event inadmissible.
- 7. The prosecution cross examined the 1st and 4th accused on statements alleged 20 to have been made to the Police: It is respectfully submitted that these statements were confessions and the leading of this evidence was contrary to law, in any event the prosecution failed to prove those statements by calling the Police Officer who recorded the statements or producing certified copies. This it is respectfully submitted (a) caused grave prejudice to the accused (b) did not give an opportunity to 30 the defence to cross examine the Police Officers who recorded these statements, (c) the defence had no opportunity of knowing what statements the accused had made to the Police as they were not available to them.
 - 8. The learned District Judge has not in his order in any way rejected this inadmissible evidence hence and in any event the Learned District Judge it is respectfully submitted has acted on evidence which was either inadmissible or had not been proved at the trial.

- 9. The prosecution in its address at the conclusion of the trial read in open Court purporting to be called 1D3 which was not placed in evidence in the Court. This document was read by the Prosecution interpreted and commented upon although the defence objected to it and wanted the objection recorded. This conduct of the prosecution it is submitted was contrary to law, the acceptance of this evidence illegal and prejudicial to the accused.
- 10. The Learned District Judge it is respectfully submitted in allowing the prosecution to amend the indictment to include a production P13 after the commencement of the trial did so illegally.

- ll. The Learned District Judge acted contrary to law in refusing an application by the defence at an early stage of the trial to send 2 documents to the examiner of questioned documents whose findings would have been material to both the prosecution and defence.
- 12. The prosecution indirectly led evidence of a confession when it drew attention of the District Judge to the statement made by an accused while leading the evidence of Sergeant Sanarakoon who has recorded same, although the Court ultimately over-ruled the admissibility of this evidence.
- 13. The depositions of the accused before the Magistrate were not legally produced in evidence before the District Judge.
- 14. It is respectfully submitted that the said judgment is contrary to law and against the weight of evidence.
- 15. As a result of the foregoing 40 grave prejudice was caused to the accused and it resulted in an unreasonable verdict.

16. It is respectfully submitted that the District Judge has failed to consider the material contradictions and glaring discrepancies in the evidence of the complainant Punchi Banda.

17. It is respectfully submitted that the Learned District Judge has misdirected himself in analysing the weight of evidence in regard to the documents placed in evidence by the defence.

The 2nd count was in respect of being armed with a deadly weapon, viz., a revolver, while being nembers of an unlawful assembly. The third was for robbery of a motor car valued at Rs.4000/while being members of an unlawful The 4th count is on the assembly. basis of common intention, which will be alternative to count 3. KURUPPU MUDIYANSELAGE PUNCHI BANDA, age 10 39 years, cultivator, residing at Eriyaulla in Pitiyagana Wasana, appears at the station and states: I own car No. EL. 5241 which is a green coloured Morris Minor. Today at about 10 a.m. I was driving car No. EL.5241 along Hiriwadunna Road towards Ranbukkana. One Nilame of Dunukewela and another boy whon I do not know also travelling with me. When we approached the boutique of N.D.S. Mudalalie at Andiramado, I noticed a 20 Ford Prefect Car following ne and a Morris Minor Waggon immediately behind it. Ford Prefect car which was about five fathons behind nine, suddenly overtook ny car and having cut across the road halted on the middle of the road at an angle. swerved my car to avoid an accident and finally halted my car behind this. At this stage the Morris Minor Waggon cane on the right side of the road facing Halpitiya. 30 Having stopped my car I attempted to get down. Innediately then a nan whom I can identify came out of the Ford car and held ne by my neck. Another man also could be identified cane from the side where Nilane was seated and pulled out the switch key. The man who pulled out the switch key and the nan who held my neck were both armed with pieces of iron. Several other people about five in number got down from the Ford car and 40 surrounded my car. All these persons were armed with knives and one person was armed

with a revolver. The person who was armed with the revolver is known to me and he is one Hendrick Appuhany of Divulapitiya. I had cash about Rs.400/- in my left shirt pocket. This money was taken by the person who removed the switch key. I was later pulled out of the car by the person who held my neck. I then went into N.D.S. Mudalalie's boutique. 10 As I left the car three persons got into my car and drove off followed by the Morris Minor Waggon. The Ford Prefect car went towards Hiriwadunna. I waited in N.D.S. Mudalalie's boutique and later after about four or five minutes I saw the Ford Prefect car going towards Polgahawela the direction in which my car and the Morris Minor wagon were driven. I did not shout for 20 help. Several persons gathered but none cane to my assistance. I do not know at what stage Nilame and the boy got down from the car but when I was in the boutique of N.D.S. Mudalalie they too came there. I did not make any attempts to shout through fear. The Ford Prefect car is white in colour and had the number EL. 8229. The Morris Minor wagon is also white 30 in colour and is a I Sri Model. do not know the exact number. EL 5241 was bought by me about three months ago from a person who is not known to me at Divulapitiya. Previous to this I owned car No. EL 3111. Ford Prefect. I gave this car to the person who sold me EL.5241 and obtained cash Rs.500/and this car. All transfer forms duly signed were obtained on this date. The 40 car EL.5241 is now registered in my name, and I have obtained the revenue licence for the year 1961, in respect of EL 5241 fron the Kegalla Kachcheri. The certificate of registration is at home. The persons who took the car fron ne have no right what-so-ever over this car. The person who held my neck is short, well built, fair, had a pointed noustache, hair

conbed back dressed in a white short sleeved shirt and white checked sarong. The person who was arned with a revolver is one Hendrick Appuhany of Divulapitiya. This person is always near the Divulapitiya Hospital and he is a car broker. He was present on the day I bought this car and he took brokerage fees for the transfer. The description of the other persons cannot be given in detail but could be identified if seen. The money I had with ne was in two fifty rupee notes and the balance in ten rupee notes. I have no injuries.
