ROAD TRAFFIC

**The M4 Motorway (Parks Farm Overbridge to Junction 18)
(Temporary Restriction of Traffic) Order 2010**

Made - - - - - *17 August 2010*

Coming into force - - - - - *20 August 2010*

WHEREAS the Secretary of State for Transport, being the traffic authority for the M4 Motorway (“the M4”), is satisfied that traffic on a length of that road between Junctions 17 and 18 in South Gloucestershire should be restricted because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) and (7) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the M4 Motorway (Parks Farm Overbridge to Junction 18) (Temporary Restriction of Traffic) Order 2010 and shall come into force on 20 August 2010.

2. In this Order –

“the M4” means the westbound carriageway of the M4 from a point at the centre of Parks Farm Access Overbridge to a point at the centre of the M4 Junction 18 Interchange;

“the hard shoulder” means the hard shoulder within the meaning of regulation 3(1)(e) of the Regulations which is adjacent to the M4;

“the Regulations” means the Motorways Traffic (England and Wales) Regulations 1982(b);

“the works” mean the installation of a new weather station sensor in the main carriageway;

“a works period” means a period of 8 hours starting at 21.00 hours on Monday 23 August 2010 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 4, no person shall, during a works period, drive any motor vehicle at a speed exceeding 50 miles per hour on the M4 and the hard shoulder.

4. The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to:

(a) a vehicle being used for police, fire and rescue authority or ambulance purposes;

(b) anything done at the direction of, or with the permission of, a constable.

5. During the works period, regulation 5 and (insofar as it relates to a vehicle being driven) regulation 9 of the Regulations are hereby suspended, in respect of the hard shoulder, at such times and to such extent as shall from time to time be indicated by traffic signs.
