**ROAD TRAFFIC**

**The M42 Motorway (Junction 3a – Junction 7) and the M6  
Motorway (Junction 4) (Temporary Prohibition of Traffic)  
Order 2010**

*Made* - - - - - *27 September 2010*

*Coming into force* - - - - - *04 October 2010*

WHEREAS the Secretary of State for Transport, being the traffic authority for the M42 Motorway (“the M42”), the M6 Motorway (“the M6”) and connecting roads, is satisfied that traffic on some of those connecting roads in the County of Warwickshire and the Metropolitan Borough of Solihull and should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14 (1)(a) of the Road Traffic Regulation Act 1984 (a), and of all other powers enabling him in that behalf, hereby makes the following Order:-

1. This Order may be cited as the M42 Motorway (Junction 3a – Junction 7) and the M6 Motorway (Junction 4) (Temporary Prohibition of Traffic) Order 2010 and shall come into force on 4 October 2010.

2. In this Order -

"the works period" means the period starting at 22.00 hours on Monday 11 October 2010 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 4, no person shall, during the works period, cause or permit any vehicle to enter or proceed in –

- (a) the link road leading from the southbound carriageway the M42 at Junction 3a to the southbound carriageway of the M40;
- (b) the link road leading from the eastbound carriageway the M42 to the northbound carriageway of the M42 at Junction 3a;

- (c) the slip roads leading to and from the southbound carriageway the M42 at Junction 4;
- (d) the slip roads leading to and from the southbound carriageway the M42 at Junction 5;
- (e) the slip roads leading to and from the southbound carriageway the M42 at Junction 6;
- (f) the link road leading from the northbound carriageway the M42 at Junction 7 to the northbound carriageway of the M6; and
- (g) the link road leading from the northbound carriageway the M6 at Junction 4 to the southbound carriageway of the M42.

**4.** The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle -

- (a) being used for police, fire brigade or ambulance purposes;
- (b) proceeding at the direction of, or with the permission of, a police constable or traffic officer in uniform; or
- (c) being used for or in connection with the said works or by a traffic officer in uniform.
