ROAD TRAFFIC

The A33 Trunk Road (A34 Kings Worthy) (Temporary Restriction and Prohibition of Traffic) Order 2010

WHEREAS the Secretary of State for Transport, being the traffic authority for the A33 Trunk Road and connecting roads, is satisfied that traffic should be restricted and prohibited on one of those connecting roads because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A33 Trunk Road (A34 Kings Worthy) (Temporary Restriction and Prohibition of Traffic) Order 2010 and shall come into force on 30th October 2010.

2. In this Order:

"the trunk road" means the A33 Trunk Road near Winchester in the County of Hampshire;

"the link road" means the road leading from the northbound carriageway of the A34 to northbound carriageway of the trunk road at Kings Worthy;

"works" mean bridge maintenance and all associated work on the trunk road;

"a first works period" means a period of 24 hours starting at 0001 hours on Monday 1st November 2010 or on any subsequent day until 29th April 2012; and

"a second works period" means a period of 8 hours starting at 2200 hours on Monday 1st November 2010 or on any subsequent day until 29th April 2012.

3. Subject as mentioned in articles 5 and 6 below, no person shall, during a second works period, cause or permit any vehicle to enter or proceed in the link road.

4. Subject as mentioned in articles 5 and 6 below, no person shall, during a first works period, drive any motor vehicle at a speed exceeding 40 miles per hour on the link road.

5. The provisions of articles 3 and 4 above shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs.

6. (1) Nothing in article 3 above shall apply to –

(a) a vehicle being used in connection with the said works;

- (b) a vehicle being used for police, ambulance, traffic officer or fire and rescue authority purposes;
- (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform;
- (d) any vehicle being used for winter maintenance purposes; or
- (e) a vehicle proceeding in the link road to or from premises accessible from, and only from, that road to such extent as shall be indicated by traffic signs.

(2) Nothing in article 4 above shall apply to a vehicle being used for police, ambulance or fire and rescue authority purposes.
